

# De to paradigmer i stærk kontrast

*Leder fra LaRouchePAC, 18. oktober 2016* – I denne uge finder der intense møder mellem europæiske og amerikanske, politiske og militære ledere sted i hele Europa, møder, hvor man diskuterer og planlægger krige – krige i Syrien, i Irak, i Yemen og i Ukraine. Det underliggende grundlag for alle disse forhandlinger er Obamas og Londons hektiske bestræbelser på at få støtte til krig mod Rusland og Kina. Europæiske regeringer og/eller ledende institutioner yder i stigende grad modstand mod dette vanvid, men Obama og hans forsvarsminister Ash Carter er i færd med at planlægge provokationer, som kunne kickstarte en irreversibel proces hen imod krig, og således true selve civilisationen med et atomart holocaust.

Og dog er det således, at det store flertal af verden ser hen til Kina, Rusland og Indien, der **i sidste uge mødtes med deres BRIKS-partnere** Brasilien og Sydafrika i Goa, Indien, hvor de kickstarter, ikke krig, men global udvikling, med højhastigheds-jernbaneprojekter, der forbinder nationer gennem en Verdenslandbro; hvor de underskriver aftaler om opbygning af kernekraft og anden infrastruktur og andet samarbejde omkring rumforskning; og hvor de løfter de mange millioner mennesker i Asien, Afrika og Sydamerika, der er ramt af fattigdom, op til en menneskelig levestandard sådan, som Kina har løftet 700 millioner sjæle op af fattigdom.

Hvilket paradigme vil afgøre menneskehedens fremtid? Den vil, et langt stykke hen ad vejen, blive afgjort af USA. Samtidig med, at krigspartiet mobiliserer sine kræfter, og i takt med, at det uafvendelige kollaps af Deutsche Banks derivatmættede aktiver spreder panik i det vestlige finanssystem, så undertrykkes Obamaadministrationens ødelæggelse og befolkningens had til Obama og hans klon Hillary Clinton kun delvist af det pornografiske klovneshow, som

præsidentkandidaterne opfører, eller som de syge medier promoverer.

## **Rusland forbereder befolkningen på mulig krig**

16. okt., 2016 – Hvis forbryderne og tåberne i Obama-administrationen bedrager sig selv med troen på, at de kan fortsætte med at true og provokere Rusland uden, at det får konsekvenser, så indtager den russiske regering et ganske andet standpunkt. ABC News rapporterede den 15. okt., at den russiske regering er i gang med aktivt at forberede det russiske folk på en mulig krig. I løbet af de seneste dage har russiske statsmedier advaret om faren for atomkrig, og en NTV nyhedsudsendelse tog seerne med på en rundvisning i atomkrigsbunkere i Moskva. TV-vært Evgenij Kiseljov rapporterede, at tre russiske missilfregatter er en route til Syrien for at imødegå en potentiel, amerikansk bombekampagne. I begyndelsen af oktober iscenesatte den russiske regering civile forsvarsøvelser over hele nationen og udførte samtidigt tre prøveaffyringer af interkontinentale ballistiske missiler – to ubådsbaserede og én landbaseret.

# **Kulturnat: Schiller Institutet indtager Folketinget: Glass-Steagall, eller kaos!**

En delegation på syv Schiller Institut-aktivister indtog Folketinget i forbindelse med Kulturnat 2016. Vores mission var at kræve, at folketingsmedlemmerne:

1. fremsætter lovforslag om Glass/Steagall-bankopdeling, og Lyndon LaRouches tre andre økonomiske love, og
2. stopper konfrontationspolitikken imod Rusland og Kina, som kan føre til krig.

Vi delte os op i to hold og begyndte at finde folketingsmedlemmer i hver deres partiværelse. Da natten var omme, havde vi talt med ca. 25 medlemmer fra alle partier, inkl. fire partiledere samt et par ministre.

Lad det være sagt med det samme – der var ingen, der lovede at fremsætte et lovforslag om bankopdeling.

Men vi advarede dem om, at de må handle nu. Det transatlantiske finanssystem befinder sig i en kritisk tilstand i forbindelse med Deutsche Bank, de italienske banker, de britiske og amerikanske banker, og selve Danske Bank har lige meddelt, at de afskediger mange tusinde medarbejdere. Det er langt værre end i 2007 – 2008, og vi har løsninger. Lyndon LaRouche og Schiller Institutet har et 4-punktsprogram for en økonomisk genopbygning, med at:

1. afskrive de nuværende finansbobler gennem en Glass/Steagall-bankopdeling;
2. skifte over til et nyt kreditsystem, som ville kunne finansiere ...

3. infrastruktur- og andre investeringer, der kunne øge hele økonomiens produktivitet (energigennemstrømningstæthed), og
4. satse på videnskabeligt og teknologisk fremskridt

Angående krigsfare, så fortalte vi nogle politikere, at selve den tyske regerings rådgiver for Ruslandsanliggender nu advarer om, at det kan komme til direkte krig mellem USA og Rusland. Og et par gange prøvede vi at give dem et andet syn på konflikten i Syrien.

Der var et par medlemmer, som ikke var interesseret i at tale med os.(fn1) Men der var faktisk medlemmer, som lyttede intenst, diskuterede med os og lovede at læse vores materiale, nogle, der sagde, at vi burde kontakte deres finansordfører angående Glass/Steagall-bankopdeling, samt et par stykker, som gerne ville mødes med os. Men de har ikke forstået, hvor kritisk situationen er, ellers ville de handle nu.

Vi kan kun håbe, at danske folketingsmedlemmer, gennem at modtage vores publikationer, gennem vores foretræder for Folketinget og gennem personlige samtaler, har fået et kendskab til Schiller Instituttets løsninger, når de, forhåbentlig, beslutter at handle.

(fn1) To af vore folk blev rent faktisk smidt ud af Folketinget, efter, at én af dem et par gange forsøgte at stille et medlem et spørgsmål, som fik ham til at flippe ud, og nogen tilkaldte en sikkerhedsvagt. Et andet delegationsmedlem blev smidt ud ved samme lejlighed, da han kunne identificeres som Schiller Institut-medlem, fordi han havde en Schiller Institut T-shirt på!

# Nøglen til sejr er at overvinde jeres frygt

*Leder fra LaRouchePAC, 17. oktober, 2016* – På netop samme tidspunkt, som BRIKS-landenes statsledere mødtes i Goa, Indien, for at planlægge samarbejdet om et nyt paradigme for statsligt samarbejde om store projekter, udsendte præsident Obama vicepræsident Joe Biden for at levere en direkte trussel mod Rusland. Søndag morgen lovede Biden på NBC TV, at USA ville gennemføre et hemmeligt cyberangreb mod Rusland, hvor Obama valgte tid og sted. Russiske regeringsfolk, herunder præsidentens talsmand Peskov, har fordømt disse trusler i de skarpeste vendinger og kalder det den mest direkte trussel om krig siden Cubakrisen i 1962.

Disse trusler kommer fra en præsident Obama, der allerede har utallige menneskers blod på hænderne, gennem sine tirsdags-»dræbermøder« og den uophørlige drone-krigsførelse, som udføres på mange kontinenter – alt sammen uden nogen forfatningsmæssigt lovlige godkendelse fra Kongressen. Nu er USA åbenlyst engageret i koalitionen krigsførelse mod Yemen, på vegne af saudierne, hvor de udfører artilleribeskydning imod Yemen fra amerikanske flådeskibe i Golfen, netop, som verden viger tilbage fra de åbenlyse saudiske krigsforbrydelser, hvor de går efter civile i bombe-razziaer i Yemens hovedstad Sanaá.

Og det er denne Obama-administration, der beskylder Rusland for krigsforbrydelser i kampen for at fravriste al-Qaeda dets kontrol over dele af den syriske by Aleppo – og som igen truer Moskva med sanktioner. Udenrigsminister John Kerry var i London i søndags, efter to dages møder i Lausanne, Schweiz, om krigen i Syrien, hvor han mødtes med den russiske udenrigsminister Sergej Lavrov og udenrigsministre fra Saudi-Arabien, Tyrkiet, Qatar, Forenede Arabiske Emirater, Iran, Irak og Jordan. Han og den britiske udenrigsminister Boris

Johnson kom ud fra deres møde i London med løfter om at indføre nye sanktioner mod Rusland – medmindre de stopper deres angreb på al-Qaeda.

Obama viderefører den tyranniske arv, der er forbundet med to tidligere Bush-præsidenter, inklusive den George H.W. Bush, som fik Lyndon LaRouches fængsling banket igennem i en hast i det, som den tidligere amerikanske justitsminister (1967-69) Ramsey Clark har kaldt det største tilfælde nogensinde af politisk motiveret anklage på baggrund af falske beviser. Politikkerne under de to Bush-administrationer, og som er blevet endnu værre under Obama, har drevet USA ud i bankerot, udslettet den smule, der var tilbage af det amerikanske sundhedssystem, og kastet millioner af husstande på fattigdommens og den kroniske arbejdsløsheds skrotplads. 93,5 millioner amerikanere i den arbejdsdygtige alder er ikke engang talt med i arbejdsstyrken! Netop i denne måned har 1,8 millioner amerikanske husstande modtaget standardbreve med posten, der informerede dem om, at deres Obamacare-præmier stiger med 50-70 %, alt imens deres dækning er blevet beskåret. Selv tidligere præsident Bill Clinton var fornuftig nok til offentligt at kalde dette »det mest sindssyge, han nogensinde har set«.

Obama og hans britiske herrer og saudiske partnere er i virkeligheden dem, der er bankerot. Det er deres transatlantiske finanssystem, der er færdigt. Som Lyndon LaRouche bemærkede søndag under samtaler med kolleger, så er den britiske økonomi totalt nedbrudt. De er desperate for at lange ud efter og fremsætte trusler imod Rusland og Kina i håb om, at deres løgne vil få fremdrift. De er bankerot, men farlige.

Kendsgerningen er, at der findes klare løsninger, begyndende med afsættelsen af Obama og den omgående genindførelse af Glass-Steagall. Hele den globale derivatboble, der beløber sig til mere end en milliard dollars, må annulleres. Når disse indledende skridt er gennemført, kan en økonomisk genrejsning omgående lanceres ved at benytte Hamiltons metoder, som det

for nylig er blevet præciseret i Lyndon LaRouches Fire Økonomiske Love.

Det første skridt i alt dette er, at førende borgere opgiver deres frygt og tager lederskabet i at bringe Dræberen Obama til fald og igangsætte den økonomiske genrejsning, begyndende med Glass-Steagall. De seneste sejre, hvor Obama er blevet tvunget til at frigive de 28 sider, der fordømmer det saudiske monarki som ophavsmændene til angrebene d. 11. september, samt Kongressens vedtagelse af JASTA-loven, illustrerer den magt, der kan udløses gennem en koncentration af patriotiske kræfter. Det faktum, at Obamas veto af JASTA blev underkendt med et overvældende, tværpolitisk flertal i begge Kongressen huse, er en kraftfuld påmindelse om, at det store flertal af amerikanerne hader Obama og alt, hvad han har gjort og står for. Saudierne forsøger at skjule det knusende nederlag, som de og Obama led i kampen om JASTA, ved at spendere \$100 millioner på lobbyvirksomhed, i forsøg på at fjerne den skete skade. De er dømt til at mislykkes.

Det, der nu er afgørende, er, at det samme niveau af mobilisering af førende borgere, der var aktive i JASTA-sejren, opretholdes og rettes mod Obama og gennemførelsen af Glass-Steagall og andre foranstaltninger.

Et afgørende træk for JASTA-sejren var Schiller Instituttets kors fire opførelser af Mozarts *Rekviem* i New York City-området på 15-års dagen for angrebene den 11. september. Det indsprøjtede en vital dimension af kulturel optimisme gennem forestillingernes skønhed – på et tidspunkt, hvor den desperate britiske fjende forsøger at begrave enhver kilde til optimisme gennem det pornografiske show, der kaldes præsidentvalgkampen 2016.

Uanset udfaldet på valgdagen, vil nationen og verden som helhed stadig være konfronteret med disintegrationen af hele det britiskværte, transatlantiske finanssystem og truslen om krig og kaos. Løsningerne for at forhindre dette kollaps er forhånden, og det er førsteprioritet på dagsordenen. Det er kilden til styrke for at overvinde vore medborgeres frygt og

opnå en hårdt tilkæmpet sejr. Det kan gøres.

# **Obama opgraderer sin afsindige 'brændte jords politik' mht. amerikansk-russiske relationer**

15. okt., 2016 – Talskvinde for det russiske Udenrigsministerium Maria Zakharova sagde ligeud den 13. oktober, at »den afgående amerikanske administration har forfulgt en 'brændt jords politik' mht. de bilaterale relationer«, en karakteristik, der fortsat bekræftes af det seneste vanvid, der kommer fra Obama-administrationen.

I et interview med NBC's »Mød pressen« den 14. okt., som vil blive udsendt i morgen, sagde den amerikanske vicepræsident Joe Biden, at »vi vil sende et budskab« til den russiske præsident Vladimir Putin, og at »det bliver på et tidspunkt, vi vælger, og under omstændigheder, hvor det vil få størst virkning«, iflg. uddrag af interviewet, som er offentliggjort af NBC. Da Biden blev spurgt, om den amerikanske offentlighed vil vide, at et budskab er blevet sendt, sagde han, »det håber jeg ikke«. Biden sagde også, at han ikke er bekymret for, at

amerikanere vil stille spørgsmålstegn ved resultatet af afstemningen den 8. november, fordi Rusland ikke har evnen til »fundamentalt at påvirke valget«.

En trykt nyhed, der blev publiceret af NBC den 14. okt., fylder billedet bag Bidens trusler ud, under overskriften, »CIA forbereder et muligt cyberangreb imod Rusland«. NBC's eksklusive rapport citerer unavngivne amerikanske efterretningsfolk, der siger, at »Obama-administrationen overvejer en hemmelig cyberaktion imod Rusland som gengældelse for angivelig russisk indblanding i det amerikanske præsidentvalg«. (Bemærk, som Zakharova også sagde, at man ikke har forelagt nogen beviser på, at Rusland skulle stå bag et hackerangreb mod det Demokratiske Parti og Hillary Clintons computere.)

NBC rapporterer, at CIA har fået til opgave at forberede muligheder for vidtrækkende, hemmelige cyber-operationer, der har til hensigt at »sætte i forlegenhed« og »chikanere« lederskabet i Kreml. De hev pensionerede admiral James Stavridis frem for at sige, at USA kunne »afsløre Putins og hans associeredes finansielle affærer«, inkl. pengeoverførsler til offshore-konti.

Dernæst nævner NBC-historien to tidligere CIA-ansatte, der hælder en spand koldt vand ud over hele den vanvittige plan. De fortalte NBC, at Det Hvide Hus har en lang historie for at give CIA opgaver med at forberede sådanne muligheder, men hver gang er de blevet opgivet. »Hvis man har til hensigt at bryde ind i deres netværk, så kan vi gøre det, men spørgsmålet bliver så, at de kan gøre værre ting mod os på andre områder.« De tilføjer: »Ingen af mulighederne var særlig gode, og vi mente heller ikke, at nogen af dem ville være særligt effektive ... vil man have Barack Obama til at udstede ugyldige checks?« Tidligere vicedirektør for CIA, Mike Morell, tilføjede: »Fysiske angreb mod netværk er ikke noget, USA ønsker at gøre, for vi ønsker ikke at skabe præcedens for, at andre lande gør det samme, inkl. imod os.«

# Italien vil sende 140 tropper til Letland

15. okt., 2016 – I går meddelte det italienske Forsvarsministerium, at Italien vil sende 140 tropper til Letland som et led i de aftaler, der blev indgået ved det seneste NATO-møde Warszawa. Selv om udenrigsminister Gentiloni insisterede på, at dette ikke er et aggressivt træk vendt mod Rusland, ser mange italienere det – og selvfølgelig russerne selv – som et aggressivt træk.

Talskvinde for det russiske Udenrigsministerium, Maria Zakharova, svarede, på et spørgsmål fra det italienske nyhedsbureau ANSA, at »NATO's politik er destruktiv. Alliancen er engageret i at opbygge nye linjer, der skiller Europa, i stedet for at opbygge dybe og solide relationer med godt naboskab.«

Oppositionsavisen *Il Giornale* sammenlignede ironisk beslutningen med Mussolinis Ruslandskampagne i 1941, ved at publicere en artikel med hovedoverskriften: »Italienske soldater imod Putin: Renzi trækker os ind i Ruslandskampagnen.«

# Moskva: USA forfølger 'den brændte jords politik' mht. amerikansk-russiske relationer

14. okt., 2016 – Talskvinde for det russiske Udenrigsministerium, Maria Zakharova, anklagede i går under sin ugentlige briefing USA for at makulere de amerikansk-russiske relationer.

»Det er med beklagelse, at vi ser Washington fortsætte med at forværre de russisk-amerikanske relationer«, sagde hun. »Vi hører, på næsten daglig basis, trusler om at udvide sanktioner og ligeledes om appeller til det internationale samfund om at følge trop«. Hun bemærkede, »Pentagon har været i gang med at opbygge sin militære tilstedeværelse langs de russiske grænser«, og »russofobisk propaganda fra nogle af de allerhøjst placerede regeringseksponenter går langt ud over det sædvanlige«. Faktisk »er der mere tale om utilslørede løgne end propaganda«, sagde hun. »Det, vi dagligt hører, om f.eks. russiske hackere, som ingen har set, men som alle allerede kender in absentia.«

»Vi har en voksende fornemmelse af, at den afgående amerikanske administration har forfulgt en 'brændt jords politik' i de bilaterale relationer«, fortsatte Zakharova. »Dette er en farlig politik, der kunne få ødelæggende konsekvenser for international stabilitet og ikke har store chancer for at frembringe nogen positiv forandring. Hvorom alting er, så bør ingen, det være sig det nuværende, amerikanske lederskab eller den forestående administration, ligge under for den illusion, at Rusland bøjer sig for pres. Den nye administration vil forhåbentlig vise sig at være mere intelligent end dens forgænger.«

Den tyrkiske vicepremierminister, Numan Kurtulmus, er tilsyneladende også meget bekymret over, hvor de amerikansk-russiske relationer er på vej hen. I et interview onsdag med *Anadolou* advarede han om, at »stedfortræderkrigene« i Mellemøsten mellem USA og Rusland kunne betyde en genopdukken af global konflikt mellem de to koldkrigs-supermagter. Krigen i Syrien er på randen til at blive en »mere udbredt regional krig«, sagde han. »Hvis denne stedfortræderkrig fortsætter, efter dette, så lad mig sige det klart, at Amerika og Rusland vil komme til et punkt, hvor de er i krig.«

## **Lyndon LaRouche: Ingen britisk militær intervention i Syrien uden USA**

*14. okt., 2016* – Briterne har kapacitet til at skabe kaos, men ikke til at føre krig, fremførte Lyndon LaRouche i dag. Dette er betydningen af gårsdagens bemærkninger fra den britiske udenrigsminister Boris Johnson, da han til en komite i parlamentet sagde, at Storbritannien er i færd med at undersøge sine militære optioner i Syrien, men at enhver aktion nødvendigvis måtte være en del af en koalition med USA's involvering, og at det ikke er sandsynligt, at dette vil ske snart.

»Det er netop nu, at vi igen bør undersøge de mere kinetiske optioner, de militære optioner«, sagde Johnson. »Men vi må være realistiske mht., hvordan disse faktisk virker, og mht. til, hvad det er muligt at levere.«

»Vi kan ikke gøre noget uden en koalition, uden at gøre det sammen med amerikanerne. Jeg mener, at vi stadig er en

temmelig lang dagsmarch fra at være fremme ved det, men det betyder ikke, at der ikke finder diskussioner sted, før det gør der sandelig.«

Den britiske premierminister Theresa May modsagde imidlertid Johnsons bemærkninger og sagde, at der ikke foreligger nogen britiske planer om militæraktion.

»Der er ingen planer om militæraktion. Vi arbejder sammen med det internationale samfund for at undersøge, hvordan vi kan bringe konflikten til en afslutning«, sagde en talsmand for May efter Johnsons bemærkninger.

Kilder i London sagde til *EIR*, at May har fokus på den alvorlige, finansielle trussel mod U.K. og City of London og ikke er villig til at risikere at miste adgangen til penge fra Rusland og Kina, som strømmer ind i City.

## **Obama sammenkalder til møde i det Nationale Sikkerhedsråd for at planlægge næste træk i Syrien**

14. okt., 2016 – Kilder i Washington har bekræftet rapporteringer om, at præsident Obama har sammenkaldt til et møde i det Nationale Sikkerhedsråd for at høre, hvilke muligheder, der er for en politik i Syrien, i lyset af de syrisk-russiske militære operationer for at udslette oprørernes sidste bastion i Aleppo. I generelle træk er fire muligheder blevet forberedt: En flyveforbudszone, en sikkerhedszone, en bombekampagne for at udslette det syriske

luftvåben samt en udvidet bevæbning af de »undersøgte« syriske oprørsgrupper. Ifølge en kilde skulle der være stærk opposition mod at bombe det syriske luftvåben, fordi det med næsten usvigelig sikkerhed ville eskalere til en direkte konflikt med Rusland.

Blandt mulighederne for at bevæbne de syriske oprørere er der en vifte af muligheder, lige fra ekstremt restriktiv bevæbning, der fokuserer på de kurdiske kæmpere i den Syriske Demokratiske Styrke (YPG for det meste), og til en langt mere bred bevæbning af oprørsstyrker, der er integreret i nogle af hardcore salafist-grupperingerne.

En anden kilde, der tidligere deltog i processen med at udvikle og fremlægge sådanne militære optioner, forventer, at Obama vil tage en specifik beslutning, baseret på tre eller fire optioner, der forelægges ham, og han vil træffe en formel beslutning og senere udstede en eksekutiv ordre.

En kilde understregede, at situationen på jorden er blevet langt farligere og nævner, at tyrkiske militære enheder har bevæget sig ind i områder, der ligger meget tæt på områder, hvor enheder fra den syriske hær opererer, så vel som også intensiteten af russiske og syriske militære operationer i og omkring Aleppo. »Truslen om en direkte konflikt med Rusland« er vokset, indrømmer kilden.

Thursday, Oct. 6, 2016

HELGA ZEPP-LAROUCHE: Good day. Thank you so much for inviting me to address your conference. The world is in a very, very dangerous situation. Everybody who watches the strategic development every day can see how the confrontation between the United States and Russia is increasing. Just a few days ago, the

official coordinator for the cooperation with Russia of the German government said in the 2nd channel of German TV, that a direct military confrontation between the United States and Russia can no longer be excluded. Now, it's not that this is something new, but the fact that a representative ... What he referred to was the complete breakdown of negotiations between Russia and the United States over the Syria crisis. And there is the immediate danger of an escalation if the policies of such people as General Petraeus or Sen. John McCain would be implemented.

And I think everybody knows that if it would come to war between Russia and the United States, it would be a global war, and it would lead to the annihilation of all of mankind in all likelihood.

Now, there is a second danger to civilization which could also lead in the end to a nuclear war, and that is that we are about to face a total collapse of the trans-Atlantic financial system, much, much worse than 2008. The IMF has named Deutsche Bank as {the} bank with the most risk in the whole global financial system, and depending on what will be the outcome of both the IMF/World Bank annual meeting in Washington right now, where the CEO of Deutsche Bank, John Cryan, went to, but also at the same time to negotiate with the Department of Justice to reduce the fine of \$14 billion which the DOJ had fined Deutsche Bank for criminal manipulations before the secondary mortgage crisis in 2007-2008, from \$14 billion to only \$5 billion, because \$14 billion would mean de facto the insolvency of Deutsche Bank.

Now, the German daily {Die Welt} said what Cryan is doing is a "chicken game," that Deutsche Bank has \$42 trillion worth in outstanding derivatives, and that is enough if Deutsche Bank goes bankrupt, to bring down the entire financial system, and according to the old wisdom, if you have enough debt you can impose the conditions how this debt will be renegotiated; but {Die Welt} basically said, this is a chicken game which nobody would survive.

Now, Deutsche Bank is maybe the worst case, but by far not the only one. Deutsche Bank, as I said, has \$42 trillion in outstanding derivatives, that is about 12 times the entire GDP of the German economy per year, and it's still about 3 to 4 times the GDP of the entire European Union. Therefore, it is obvious that if Deutsche Bank collapses, neither the bail-in law which is by now law in the entire European Union, nor bail-out would be sufficient to solve the problem. And if you look at the engagement of these derivatives with the banks which are counterparty to Deutsche Bank, it involves the entire too-big-to-fail banking system of the trans-Atlantic system, and if Deutsche Bank goes without state intervention, and that is obviously not the solution either, it could be like the super-nova, basically evaporating in a very brief time.

A similar situation is true for the Italian banks, for the British banks after the Brexit, and one should not overlook that all of these banks have large fines to pay for crimes. Deutsche Bank had to pay because they manipulated and cheated the customers in the real estate market in the United States.

Wells

Fargo just had a hearing in the U.S. Congress because they set up

2 million fraudulent, fictitious bank accounts to steal. Then you have HongShang banking corporation, which is openly laundering the entire drug money of the Mexican drug mafia.

They

all were involved in the LIBOR manipulation, which caused the three-digit billion losses for the customers.

We are for sure heading towards an October crisis.

This is

not going to be a crisis after the U.S. election: This is now.

And all the means of the central banks, quantitative easing they

have been doing since 2008; negative interest rates, which kills

the savings of the population; and now they're talking about "helicopter money" which is really the last straw. All of these

tools do not function any more.

There is a remedy, and that is, you have to implement immediately the Glass-Steagall banking separation law, exactly what Franklin D. Roosevelt did in 1933. Lyndon LaRouche has enlarged that conception to say, we need Glass-Steagall, that is,

you have to write off the speculative part of the banks; but then

you have a lack of liquidity and therefore, you have to have a credit system in the tradition of Alexander Hamilton, which issues new, large credits for productive investments. But you also have to increase the productivity of the economy, you have

to have a science driver, and the best for that is international

space cooperation and vanguard technologies which go along with

that.

We also need what Roosevelt did at the time, a Pecora Commission. Pecora was the New York State attorney, who investigated the CEOs of the Wall Street banks under oath at the time, to then send many of them to jail. And as a leading banker contact told us, if you don't do that, you cannot reinstate the confidence in the banks, because people have lost completely confidence in the system which is obviously more criminal than not.

There is good reason that this can be done. Because in the United States both parties, the Republicans and the Democrats, have the Glass-Steagall Act in their platforms and despite the fact that Hillary Clinton is not for Glass-Steagall, it is important that in times of crisis such provisions are there. And there is a renewed optimism that you can mobilize the Congress, even if normally people have little hope that the Congress will do something useful, they just did by voting up the JASTA bill overriding the veto of President Obama in respect of the ability of the families of the victims of September 11th, to sue the Saudi government. This is a tremendous victory, because what was victorious in this situation was a sense for justice: That it was completely unjust that the victims of the September 11th terrorist attack would not have the ability, and the families in particular would not have the ability, to bring the criminals responsible for that terrorist act to court. And that has now occurred, and there is a tremendous sense that you can move, once

people are united for a good plan, and once they act together.

Now, there is an equal yearning for justice concerning the banking system. The banking system which has provided unbelievable profits for a few, where bankers which provably are criminal can get away with bonuses of hundreds of millions of dollars, while the people they are looting, more and more of them become completely impoverished.

The other important aspect about this is that the alternative financial system is already in place. Since 2013, when President Xi Jinping announced the New Silk Road, there has been an unbelievable development, in the tradition of the ancient Silk Road of 2,000 years during the Han Dynasty, which at that time was an immense exchange, not only of goods, but of culture, of ideas, and most importantly of technologies, of the ability how to produce silk, how to make porcelain, and other such vanguard technologies of that time; the idea is now that the same kind of exchange has been occurring since three years among the nations of the New Silk Road, but with modern technologies.

This is the largest infrastructure plan in all of human history: It's about twelve times larger than the Marshall Plan was which was helping to reconstruct Europe after the Second World War, in terms of actual buying power. It right now encompasses \$1.4 trillion; it already involves 43% of the world economy, and 4.4 {billion} people, 70 countries, are cooperating around it. It is the only long-term development strategy under

the leadership of China right now. As a matter of fact, it's the only strategic plan to overcome this present geopolitical confrontation I mentioned in the beginning, because it is based on the idea of a "win-win cooperation" of all countries on this planet.

Very important, in respect to the financial crisis, these countries have started to set up an alternative financial system.

They have started the Asian Infrastructure Investment Bank (AIIB), where immediately about 70 countries wanted to be founding members, despite enormous pressure from the United States not to do so. Even close allies of the United States, like Great Britain, Japan, South Korea, Germany, France, and Canada, they all wanted to be founding members of this new bank,

which has a starting capital of \$100 billion, which can be expanded, and will be. They also have created the New Development Bank, that is the bank of the BRICS countries; the New Silk Road Fund of \$40 billion; the Maritime Silk Road Fund;

the Shanghai Cooperation Organization has created a new bank; and

they have created something called the Contingency Reserve Arrangement which began as a pool of \$100 billion, helping the BRICS countries and other developing countries to fend off manipulative speculative attacks like those of George Soros and other speculators.

It is very important that this idea of the New Silk Road is expanding with an unbelievable speed, and many countries, not only in Asia, but also in for example, Eastern and Central Europe

are picking up on it. There is now a cooperation between China and Greece, Serbia, Hungary, Czech Republic and even Poland, all working on high-speed trains on infrastructure cooperation. And the idea is to extend this kind of a New Silk Road into the Middle East and into Africa, to address the very, very dramatic situation there, to reconstruct the Middle East after the war, and to develop Africa, so that also the refugee crisis, which is one of the largest humanitarian crises in the world ever, to create conditions where Africa and Southwest Asia are being industrialized so that people do not want to leave their home, but rather, help to build up their nations.

All of this is not just business. The Silk Road is by no means only infrastructure in the narrow sense, connecting A to B through trains and ships, but it is also not just a replacement of American imperialism by Chinese imperialism, which is what some media are trying to insinuate. The New Silk Road, put on the agenda by China, is truly a completely different model of cooperation among states: It is based on dialogue, partnership and cooperation; and China does not want to be a new hegemon, but wants to have cooperation with all countries based on a "win-win" mutual benefit, where each country has their own advantage.

China has said many times, as a matter of fact, Xi Jinping has used the formulation that what is needed is a "community of shared destiny." Now, this is what the Schiller Institute has

promoted for 25 years when we proposed the Eurasian Land-Bridge when the Soviet Union collapsed, and expanded it in the 25 years since, that the Silk Road must become the World Land-Bridge, we always have said that we need a completely new paradigm based on "win-win cooperation"; and that is exactly what is now pushed by China.

Now people always have suspicions, "what is the real aim of China?" But I have come to the absolute conclusion, that China {means} exactly what they're saying, that the world must not be run on the basis of a zero-sum game, but on the idea of a harmony of all nations.

Now, 2016 is the 2,567th birthday of Confucius and you have right now a total revival of Confucian philosophy, in all of China, in all schools, universities, cities, and there is right now a two-and-a-half-thousand-year-old history of Confucian tradition in China, with the very short except of the ten years of the Cultural Revolution. And that has shaped the Chinese mind to a very large extent, the Confucian idea that the world should be organized in a harmonious way, by allowing the harmonious development of all nations, of all families, of all individuals; and that a country cannot do well, if its neighbors are not doing

well. The idea of Confucius that politics must be based on love, now that is associated with the idea that politics has only one aim, and that is the happiness of people, an idea which used to belong the American Declaration of Independence, and an idea which is also very, very known in the history of European humanism.

Confucius also taught that people have to have a lifelong learning, and that they should perfect themselves without limit, and that the highest ideal of man is the {chun tzu}, the wise man who is basically perfecting himself in the highest degree. And out of this comes the idea that the sage king is morally much more attractive than the hegemon. This is the same idea as Plato's "philosopher king," that only the wisest and most moral people should rule.

Now, while the hegemon rules by forcing the underlings into submission, the wise king and the wise leadership is elevating the people through inspiration. At the recent G20 meeting in Hangzhou, which occurred for the first time under the leadership of China, they have made a wonderful proposal to put the whole world economy on the basis of innovation and to share whatever scientific and technological breakthroughs are being made, immediately, with all other nations, but especially the developing nations, so that their development is not being held up.

Since then, they have announced scientific and technological

cooperation among the countries along the New Silk Road; they opened up science and technology parks, huge exchange of scientists and youth, in order to spread these ideas in the quickest possible way. All of these policies are a reflection of the Confucian philosophy.

If you study it more closely, you will realize there is a tremendous affinity between Confucian thinking and European humanism. They are much closer and much more related than most people are aware. While in China, a Confucian Renaissance is fully underway, it is the West which is in urgent need of such a cultural renaissance.

The Western world has plunged into a terrible moral degeneracy and decadence: If you look at the drug addiction, for example, well the case of Mexico, for example, is famous: The drug lords have taken over much of the country. But in the United States the drug addiction is the most important cause for the rising suicide rate which has quadrupled since 2001, since Bush came into office, suicides in all age groups. If you look at the violence in the United States, but also in other Western parts, you have the police violence, you have the school shootings, you have pornography, you have the total brutalization of behavior, which almost is a breakdown of civilized relations among people. I don't want to go into this more deeply, because you all know it.

So we need urgently, if you want to save humanity, we need a

Renaissance of Classical culture. We have to go back to an image of man which emphasizes that, which separates man from all other living species and that is the creativity of the mind of the human being. The problem with popular culture is that it {de}-emphasizes this creativity. Pop music, for example, if young people go to discos, it almost always goes along with drug consumption, with something which destroys the creative faculties of the mind.

We need a Classical culture which emphasizes the beauty of the best traditions of Greece, for example, Greek architecture, Greek historical dramas, Greek philosophy, but also the beauty of Dante, of Petrarca, of the Italian Renaissance; in the Spanish culture, of the Andalusian renaissance, of Cervantes, of Goya; in Germany, the Schiller, Beethoven, and many other great thinkers.

Now, why is Classical culture so absolutely important? Rather than being a soap opera, where you add irrational emotions one after the other, without rhythm or rhyme, you have in Classical culture either a poetical or a musical idea, and then, according to very strict principles of composition, you develop that idea until it is exhausted, in a thorough-compositional way; and then you come to a conclusion on a higher level of reason. And when you train your mind in this way, in Classical thinking, you become more creative. And it also leads to an education

of  
the emotions. Because if you only rely on your senses, you  
are  
just reacting. That is why Friedrich Schiller demanded the  
aesthetical education of man: Namely, through Classical art,  
the  
aesthetical education teaches man to feel more noble and to  
education your emotions up to the level of reason, so that you  
can blindly follow your impulses because they will never tell  
you  
anything different than what reason commands. This is why we  
have  
to reintroduce beauty into art, and the great German poet  
Friedrich Schiller said "Art which is not beautiful should not  
be  
called art."

In the Greek Classical period, you had the ideal of  
the  
identity of the beautiful, the truthful, and the good. And  
you  
cannot be truthful if you are not trying to develop the idea  
of  
beauty, and you cannot develop the good without being  
truthful.  
So there is an inner connection between these because they  
address the same faculty in the human mind.

The future of mankind very clearly will be in space.  
If you  
look at the evolution of man, or even of life as it developed  
through photosynthesis from the oceans to land, from lower to  
higher species, and eventually the creative mankind, man  
settled  
at the rivers and oceans first; then through infrastructure  
development, opened up the landlocked areas of continents. And  
now with the New Silk Road we are completing that phase of the  
evolution, where man through infrastructure, develops the  
landlocked areas of all continents. And the natural extension

of  
that infrastructure development will be the opening up near  
space, probably first a colony on the Moon, and that will be  
the  
launching pad for future space operations as our energy  
sources  
become more dense, and we will be able to even understand much  
better what is the position of our planet in the Solar System,  
in  
the Galaxy, and we will develop a much deeper understanding  
about  
the laws of the universe and the relationship of creative  
mentation to that Universe, because our mind is obviously not  
outside of the universe, but it's part of the universe, and it  
is  
the most developed part.

A lot more studies have to be made about that connection  
between the mind and the universe at large, and the better we  
understand that connection, the more rational we will become  
as a  
human species. The great German space scientist Krafft  
Ehrlicke  
developed the beautiful notion of the "extraterrestrial  
imperative," saying that man only becomes truly adult when we  
try  
to understand and conquer space more deeply, because man will  
only become fully rational when we do that. And Krafft  
Ehrlicke,  
who was a close friend of ours, said at the end of his life,  
that  
the importance of great Classical art was absolutely crucial,  
because if science is developed that does not yet say whether  
it's applied for something good, or for something bad; it is  
always man who applies that science which makes the  
difference.  
And therefore, the aesthetical and moral education to beauty  
and

to the good is what will make the longevity of the human species possible.

Now, this is why we are saying, so emphatically, that the economic development of the New Silk Road must be combined with a Classical Renaissance of Classical culture, and that we must bring forward the best traditions of each culture, of Chinese poetry and philosophy, of Chinese painting, of Indian philosophy, of African wonderful philosophical contributions from the time of Timbuktu; of other great cultures, which each, at one point had a high phase in their culture, like the Arab Renaissance of the Abbasid Dynasty at which point the Arab culture was the most developed.

What we have to do, is we have to make the best phases of these periods known, and then have a dialogue between these cultures and then out of that will generate love for the other culture; and we will indeed reach a new paradigm of civilization.

If we make that cultural universal heritage known to all children, in the universal education, I think the future will be that such geniuses as Bach, Schiller, Einstein, will not be such an exception. There will never be a second Einstein, but we will have many, many geniuses because we will provide children with a much, much better opportunity to unfold all the potentials which are embedded in them.

Now, I think we are not only on the verge of a potential global war, but with the New Silk Road we are also at the edge of entering a completely new paradigm of civilization, what I like to call the "adulthood of mankind," and not any more behaving like stupid two-year-old little boys kicking each other in the knee.

So we are really at an important historical moment, and I would ask all of you to join in a Renaissance movement, because I'm absolutely optimistic that if all good people on the planet are working together to this aim, we can do it.

Dette er en absolut realistisk fare, men fakta om denne akutte fare og måden, den fremstilles på i den overvejende del af de vestlige medier, kan kun anses for at være direkte propaganda som forløber for krigen, hvor den forestående krigsmodstander, i dette tilfælde Putin, dømmes. Den syriske befolknings lidelser er uudholdelige, men begivenhedernes rette kronologi forties. Hvem er ansvarlig for politikken med regimeskifte? Udenrigsministrene Kerry og Lavrov havde netop forhandlet en våbenstilstand for Syrien på plads, da det amerikanske flyvevåben »ved en fejltagelse« bombarderede nogle syriske hærstillinger, hvis position havde været kendt i et halvt år, dræbte 60 soldater og sårede yderligere hundrede, for dernæst, uden nogen som helst beviser, at gøre de russiske styrker ansvarlige for angrebet på FN's nødhjælpskonvoj. Heraf drog den russiske regering den slutning, at Obama-administrationen ønskede at sabotere Kerrys strategi, og opsagde aftalen om afskaffelse af plutonium, der kan anvendes i våben, samt bekendtgjorde deployeringen af missilforsvarssystemerne S-300 og S-400 til Syrien. Situationen taget i betragtning udgør kravet om oprettelse af flyveforbudszoner og såkaldte sikkerhedszoner langs den tyrkiske grænse, der naturligvis kun kan gennemføres med militære midler, en direkte hensigtserklæring om en konfrontation med Rusland.

Talsmanden for det russiske Forsvarsministerium, Igor Konasjenkov, advarede alle dem, der legede med tanken om direkte militære operationer mod den syriske hær, om, at S-300- og S-400-missilforsvarssystemerne havde nogle overraskelser til dem og advarede mod den illusion, at de skulle kunne indsætte *stealth*-fly. Den russiske viceudenrigsminister Sergej Ryabkov kommenterede Washingtons udmelding om at indstille alt samarbejde med russerne om Syrien med, at beslutningstagerne i USA ikke lod sig lede af kølige overvejelser, men af følelser, og sagde: »På baggrund af det dybe, følelsesmæssige sammenbrud, vi kan iagttage, kan de træffe en hvilken som helst beslutning.«

Man kan med god samvittighed gå ud fra, at beslutningstagerne bag kulisserne i USA heller ikke mht. det transatlantiske finanssystems tilstand lader sig lede af kølige overvejelser. For, hvis dette var tilfældet, så ville de indrømme det

neoliberale, monetaristiske systems bankerot og gå i gang med en omgående reorganisering af dette på basis af en global Glass/Steagall-bankopdeling. I stedet forsøgte IMF og Verdensbanken, ved deres halvårlige møde i Washington, at videreføre deres mislykkede politik og fremførte det hårrejsende argument, at det er opkomsten af alle de populistiske protestbevægelser mod deres politik, der er ansvarlig for krisen, hvilket er lige så absurd som kravet om, at Kina og Indien skal indstille deres kreditudstedelser. IMF kritiserer lige præcis verdensøkonomiens eneste to vækstmotorer!

I private samtaler mellem nogle af deltagerne på mødet herskede der derimod åbenlys forfærdelse over den kendsgerning, at hele det europæiske og amerikanske banksystem ikke blot er håbløst bankerot, men at dets kriminelle karakter desuden havde medført noget, der er dødbringende for finanssektoren, nemlig en total tillidskrise. Det udtalte problem var og forbliver fortsat Deutsche Bank med dens eksponering til derivater til 42 billioner euro – et beløb, der er omkring tolv gange så stort som hele den tyske økonomis årlige bruttonationalprodukt! Og alle de banker, der angiveligt skulle være for store til, at man kan lade dem gå ned, er modparter i Deutsche Banks derivatkontrakter og kunne blive revet ned i afgrunden sammen med den. *New York Times* klagede, at Deutsche Bank kunne vise sig at blive den nye Lehman Brothers og citerede Harvard-professoren Hal Scott, der sagde, at han håbede, der fandtes en global strategi for denne kendsgerning – for intet mindre end dette ville være i stand til at løse problemet.

For at afvende den nedsmeltning af det transatlantiske finanssystem, der står umiddelbart for døren i oktober eller allersenest november, og som ville føre til et globalt kaos og bringe krigsfare op på kogepunktet, er der hidtil kun fremsat ét eneste anvendeligt forslag: En omgående, koordineret indførelse af de **Fire Love**, som Lyndon LaRouche allerede den 18. juni, 2014, foreslog:

\* **For det første:** Den omgående genindførelse af

Glass/Stegall-bankopdelingsystemet, og vel at mærke i den totalt uforandrede form, som Franklin D. Roosevelt satte i kraft i 1933. Dette ville i praksis betyde afskrivning af langt den største del af den ubetalelige gæld og de udestående derivatkontrakter.

\* **For det andet:** Der må, i hver eneste stat, oprettes et nationalt banksystem i traditionen efter Alexander Hamilton, og som erstatter kreditgivningen fra angiveligt uafhængige centralbanker til gunst for spekulanter, gennem det eksempel, som Hamilton skabte, og som blev anvendt af Lincoln, Franklin Roosevelt, såvel som også af den tyske Kreditanstalt for Genopbygning (*Kreditanstalt für Wiederaufbau*), til at genopbygge Tyskland (efter Anden Verdenskrig, -red.).

\* **For det tredje:** Der må skabes et internationalt kreditsystem, hvis opgave er at øge produktiviteten i realøkonomien og befolkningens levestandard i alle nationer, hvilket kan finde sted gennem fremme af videnskabeligt og teknologisk fremskridt og en reel forøgelse af energigennemstrømningstætheden i produktionsprocessen.

\* **Og for det fjerde:** Videnskab som drivkraft for økonomien, som kan opnås gennem et forceret program for at beherske og anvende kernefusionsteknologi, såvel som gennem et internationalt samarbejde om rumfart.

Det kommer ikke som nogen overraskelse, at tilskyndelsen til en sådan reorganisering af finanssystemet ikke kommer fra USA eller Europa. Det, der kommer nærmest til LaRouches forslag, blev derimod fremlagt af Kina på det seneste G20-topmøde i Hangzhou, hvor de her foreslog en ny, global finansarkitektur og en nyorientering af verdensøkonomien på grundlag af innovation og vækst. Man kan således gå ud fra, at disse forslag vil blive genstand for nye initiativer på BRIKS-staternes årlige konference, i år i Goa, Indien, midt i oktober. Betydningen af de banker, som er blevet skabt af Kina og BRIKS-landene, såsom Asiatisk Infrastruktur-Investeringsbank (AIIB), Den nye Udviklingsbank (NDB; 'BRIKS-banken'), Silkevejsfonden, den Maritime Silkevejsfond, såvel som Valutareservefonden (BRIKS' Contingency Reserve

Arrangements), vil vokse.

Med hensyn til USA, så har LaRouche krævet, at den amerikanske Kongres omgående vender tilbage fra valgkampen (i de enkelte medlemmers egne valgdistrikter, -red.) til Washington, for omgående at vedtage Glass/Steagall-loven. Dette er, i betragtning af Wall Streets skarpe modstand mod denne lov, ganske vist ingen nem opgave, men Wall Streets magt er skrumpet voldsomt på grund af befolkningens vrede over den kriminelle karakter af mange af disse banker, som ikke mindst pga. de voksende bøder for deres bedragerier er ved at gå bankerot. Salg af giftige værdipapirer til godtroende kunder, manipulation med LIBOR-rentesatsen, oprettelse af millioner af falske konti, forfalskede regnskaber, pengehvidvask osv. – listen er alenlang.

I Amerika har LaRouche-bevægelsens udbredte mobilisering, sammen med familierne til ofrene for 11. september, førstehjælpsfolk, brandmænd og andre institutioner, ført til den banebrydende succes med Kongressens afstemning, hvor præsident Obamas veto mod JASTA-loven blev underkendt. Til denne succes kommer yderligere de mere end to hundrede organisationer, der har til hensigt at gøre kongresmedlemmernes og senatorernes holdning til Glass-Steagall til det afgørende kriterium for at vælge dem til november, og som nu vil konfrontere kongresmedlemmerne med deres ansvar i disses egne valgkredse.

Vi må, gennem en bred mobilisering af befolkningen, også tvinge parlamenterne i Europa til omgående at afslutte kasinoøkonomien ved at indføre en Glass/Steagall-bankopdeling, sætte en ny kurs for den økonomiske politik i overensstemmelse med LaRouches Fire Love og, sammen med Kina og Rusland og et forhåbentligt, gennem Glass-Steagall, reorganiseret Amerika, genopbygge de lande, der er blevet ødelagt af meningsløse og barbariske krige. Opbygningen af Den nye Silkevej til at strække sig ind i Melleømsten og det øvrige Sydvestasien, samt Afrika, er her ikke blot den eneste humane løsning på flygtningekrisen, men også et spørgsmål om Europas moralske

overlevelse.

Krigsfarens kan kun overvindes, hvis vi i stedet for den geopolitiske konfrontation indfører et helt nyt paradigme for internationalt samarbejde omkring menneskehedens fælles mål.

# Hadekampagne mod Putin og Rusland eskalerer ud af kontrol

12. okt., 2016 – Hadekampagnen imod Rusland og imod præsident Vladimir Putin eskalerer time for time og skaber et klima for en total krig. Dagens *New York Times* tog føringen med en lederartikel, underskrevet af redaktionen, og som fortsatte med at anklage GOP-præsidentkandidaten Donald Trump for at være »Hr. Putins puddelhund«, fordi han nægter at køre med den anti-russiske klat.

»Det er uacceptabelt, at hr. Trump nægter at acceptere Ruslands rolle med at støtte Syriens brutale diktator, Bashar al-Assad, og at fordømme de bombardementer, der har dræbt tusinder af civile i Aleppo og andetsteds. I stedet ignorerede han borgerkrigen og roste faktisk ikke alene Rusland, men også hr. Assad og Iran for at 'dræbe ISIS', Islamisk Stat.

*The Times* publicerede ligeledes en hysterisk svada om Ruslands anvendelse af »maskirovka«, misinformation, som en del af krigsførelsen, og nævnte invasionen af Krim, deployeringen af russiske soldater i civilt tøj til det østlige Ukraine, samt beskyldningen om, at det var amerikanske droner, og ikke russiske bombefly, der angreb nødhjælpskonvojen i Syrien i sidste måned.

»Eksperter frygter«, skrev *Times*, »at det næste teater for sådanne taktikker kunne blive det baltiske område, hjemsted for betydelige minoriteter af etniske russere, så vel som også hjemsted for en stor, russisk militærbase i Kaliningrad.« *Times* opdigtede dernæst et scenarie for en russisk invasion i de baltiske stater, under dække af et handelsskib, der går på grund og leverer påskuddet for en begrænset, russisk troppeinvasion.

En artikel i *Foreign Policy* af Peter Rough har overskriften, »Den bedste måde at besejre Islamisk Stat og lykkes i Syrien? Træng Putin tilbage.« Artiklen anklagede Rusland for at ignorere mange tilbud fra Vesten om at samarbejde i Syrien, fordi Rusland forfølger en politik for kontrol over hele korridoren fra Damaskus, gennem Latakia til Aleppo, og krævede en barsk, amerikanskstøttet modstand mod den russiske tilstedeværelse i Syrien. Rough foreslog, at, med sammenbruddet af Kerry-Lavrov-diplomatiet, står Obama umiddelbart for at sammenkalde til et møde i det Nationale Sikkerhedsråd for at afgøre, hvordan man skal optrappe i Syrien. Forfatteren krævede en betydelig opgradering af den amerikanske støtte til syriske oprørere, der bekæmper regimet i provinserne Homs, Idlib og Aleppo.

»Medmindre USA er med til at forme en ny, regional orden, der giver magt til disse moderate sunni-arabere imod shia-dominans, er vi dømt til et evindeligt nak-en-muldivarp-spil i hele området.« Rough støttede fuldt ud den tyrkiske invasion af det nordlige Syrien, der er rettet mod kurderne, og tilføjede, at »Obama-administrationen aggressivt bør bakke op om Tyrkiets støtte til den Frie Syriske Hær i provinsen Aleppo.« Han opfordrede også til, at USA skulle bevæbne og støtte en nyligt dannet Frie Idlib-hær. Rough sluttede med at opfordre Kerry til at træde tilbage, hvis Obama ikke bemyndiger en stor, amerikansk militæroptrapning for at »påføre Rusland, Iran og Assad meningsfulde omkostninger«.

I en tale på en Atlanterhavsråds-konference i Washington den

6. okt., opfordrede NATO's tidligere generalsekretær Anders Fogh Rasmussen de europæiske NATO-lande til at øge deres forsvarsudgifter, alt sammen rettet mod Rusland. Han fremførte, at Putin kun respekterer »en magtdemonstration«, og at det er den eneste måde at standse ham i at iscenesætte en direkte konfrontation med NATO i Europa.

## **Lad jer ikke intimidere af Obamas og briternes løgne og tomme trusler**

*Leder fra LaRouchePAC, 12. oktober, 2016* – På vegne af det britiske system er præsident Barack Obama engageret i en stor løgnekampagne, med trusler om krig mod Rusland og Kina. Briterne er ved at blive vanvittige over udsigten til det totale tab af magt, i takt med, at deres transatlantiske finanssystem står til at kollapse. Man har nu åbent indrømmet, at Den Europæiske Centralbank mørklagde Deutsche Banks

bankerot, da den gennemførte de såkaldte stresstests i slutningen af sidste år. Ikkeeksisterende aktiver, der stammede fra salg, der aldrig fandt sted, blev af Deutsche Bank bogført som kapitalreserver for at skjule det faktum, at de er dømt til undergang, medmindre de underkastes en total omstrukturering, hvorunder deres derivatbeholdning på 46 billioner euro annulleres og banken atter gøres til en traditionel, tysk detailbankvirksomhed. HSBC, flagskibet i City of Londons offshore narkotikaimperium, udsendte onsdag en nødvarsel om et umiddelbart forestående sammenbrud af den transatlantiske aktiemarkedsboble.

Tidligere NATO-generalsekretær Rasmussen opfordrede europæiske stater til at begynde en massiv oprustning med henblik på at konfrontere russiske trusler, hvilket er et komplet bedrag. De europæiske stater er bankerotte, og der er allerede en voksende modreaktion i Tyskland og andre steder mod forslaget om nye sanktioner mod Rusland.

I Syrien er bundlinjen den, at USA, Storbritannien, Frankrig og Golfstaterne har brugt milliarder af dollars på at opbygge en hardcore Islamisk Stat og en al-Qaeda-terroristorganisation for at vælte Assad-regeringen, og Vladimir Putin greb ind og ødelagde deres plan. Nu er den syriske hær, med russisk støtte, på nippet til at knuse disse terrornetværk i Aleppo. Så derfor beskylder franskmændene, briterne og Obama-administrationen alle Putin og Rusland for krigsforbrydelser i Syrien, alt imens de er engageret i deciderede forbrydelser mod menneskeheden i Yemen. Obama-administration truer nu med en direkte militær intervention for at styrke de patetiske saudiere, hvilket blot yderligere ville udvide listen over forbrydelser mod menneskeheden, som Obama begår.

# **Xiangshan Forum for Internationale Relationer: Kun udvikling kan gøre en ende på dette kaos**

Forummet har temaet, »Opbyg en ny type internationale relationer gennem dialog om sikkerhed og samarbejde«, og det fokuserer stærkt på global sikkerhed og terrorisme. Forummet får fremtrædende dækning på både de russiske og kinesiske, engelsksprogede nyhedssites. Ifølge forummets arrangører deltager over 400 personer, inklusive delegationer fra 59 lande, seks internationale organisationer, kendte politikere og eksperter.

Den kinesiske forsvarsminister Chang Wanquan sagde i sin åbningstale, at verden i dag gennemgår hidtil usete forandringer.

*»På den ene side er fred, udvikling og win-win-samarbejde tidens trend, med lande, der er tættere forbundet end nogensinde tidligere, og med opkomsten af udviklingslande, især de fremvoksende økonomier, der skubber det internationale magtlandskab over mod en ligevægt«,*

sagde han.

*»På den anden side konfronteres den globale fred og udvikling med nye trusler og udfordringer, og vi bør nøje overvåge nogle nye tendenser i den internationale sikkerhedssituation.«*

Chang knyttede også sikkerhed og udvikling tættere sammen.

*»Krige, konflikter, terrorisme og flygtningekriser har alle deres rødder i en tilbagestående udvikling, og den endelige løsning på disse problemer bør også søges gennem udvikling«,*

sagde Chang. Ifølge Changs mening er den globale, strategiske stabilitet truet, hvilket bevises af

*»visse landes forstærkede militære alliance for at opnå absolut militær dominans og for at søge deres egen, absolutte sikkerhed på bekostning af andre landes sikkerhed. Vi bør afvise den Kolde Krigs forældede mentalitet«,*

sagde Chang og tilføjede, at landene i verden i deres internationale samarbejde bør prioritere *»skabelsen af den nye, globale sikkerhedsarkitektur«*.

# **Obama, og USA's økonomi, er ved at smuldre**

## **– Vil Obama trække verden med sig ned?**

*Leder fra LaRouchePAC, 11. oktober, 2016* – Det amerikanske folk har for nylig vist et usædvanligt og særdeles velkomment mod og en ditto optimisme med den kendsgerning, at de knuste Obamas åbenlyse støtte til sponsorer af terrorisme og underkendte hans veto imod JASTA-loven således, at man kan gå frem med juridiske sagsanlæg imod saudierne for deres rolle i 11. september-angrebene mod USA. Der er nu, fra Obamas og briternes side, en samlet indsats for at knuse denne optimisme og dette mod, hvor de bruger deres talsmænd og pressehorerne til at skræmme befolkningen til at acceptere en krig mod Rusland og Kina. Denne indsats kan og må afsløres og nedkæmpes.

Et sindssygt initiativ for krig er, fra forsvarsminister Ash Carters side, blevet lanceret siden JASTA-sejren, lige fra hans krav om en \$1 billion stor modernisering af USA's atomvåbenlager som forberedelse til at bekæmpe »russisk aggression« og til den britiske forsvarsminister og det britiske Underhus' medlemmer, der skriger op om, at vi nu må i gang med at nedskyde russiske fly i Syrien, og til, at Obama personligt trækker tæppet væk under Kerry-Lavrov-planen for en våbenhvile i Syrien.

Men, Obama er færdig, afsløret som en fiasko på enhver måde – Obamacares kollaps, den produktive beskæftigelses kollaps, afsløringen af hans støtte til den saudisk sponsorerede terrorisme, hans rolle som massedræber gennem sine ulovlige krige for »regimeskifte« og sine dronedrab af mænd, kvinder og børn. Vil han nu have held til at trække os ind i en atomkrig,

eller vil det amerikanske folk genvinde sit mod og sin optimisme og fjerne ham fra embedet?

Russiske og kinesiske militærledere, der mødtes i dag ved det 7. Xiangshan Forum i Beijing, udsendte en advarsel, der sendte kuldegysninger gennem knoglerne, om, at Obama-administrationen er langt fremme med at forberede sine styrker til at lancere en førsteangrebs-atomkrig imod begge nationerne. Med nævnelse af den operative, amerikanske krigsdoktrin, *Prompt Global Strike*, (Globalt Førsteangreb), og idet han især påpegede deployeringen af antiballistiske missilsystemer langs med både de russiske og de kinesiske grænser, sagde generalløjtnant Viktor Poznikhir fra den russiske generalstab:

*»Russiske militærekspertter siger, at USA, med besiddelsen af dette [missilforsvarssystemet], håber at få mulighed for at levere et overraskelses-atomangreb hvor som helst i verden, inklusive mod Rusland og Kina, og at det går ustraffet hen.«*

Prompt Global Strike, forklarede han, er baseret på den fantasi, at de nye missilsystemer, ved at gennemføre angreb, der afvæbner modstanderens atomstyrker, kan tilintetgøre modstanderens evne til at gennemføre et angreb som gengældelse for et førsteangreb.

På det samme forum sagde den kinesiske generalmajor Cai Jun fra den Centrale Militærkommissions Fællesstab:

*»Gennemførelsen af planerne om at udvikle missilskjoldet er i færd med at ødelægge den strategiske balance og stabiliteten, og ligeledes forværre situationen i sfæren for global sikkerhed. I øjeblikket har USA magtfulde styrker til generelle formål, og har ligeledes en betydelig, kvalitativ overlegenhed i sfæren for strategiske atomstyrker. Tilsammen udgør disse komponenter moderne væbnede styrker og gør det muligt at gennemføre konceptet i doktrinen, 'Prompt Global Strike'.«*

General Poznikhir tilføjede:

*»Rusland må nødtvungent tage passende modforholdsregler for at forhindre USA og dets allierede i at øve indflydelse på den eksisterende styrkebalance inden for den strategiske våbensfære. Så vidt vi forstår, så handler vore kinesiske partnere på samme måde.«*

Er Obama så narcissistisk, at han tror, han kan forlange, at et atombevæbnet Rusland og ditto Kina bøjer sig for hans krigstrusler og hans igangværende forbrydelser for at gennemtvunge regimeskifte over hele planeten?

Kun briterne kan matche Obama med hensyn til krigsmagerhysteri. I dag afholdt det britiske Underhus en særlig samling om Syrien, hvor både Blair-tilhængere og Toryer (det Konservative Parti) krævede en krig mod Rusland over Syrien, og hvor de karakteriserede Ruslands krig mod terrorister i Syrien som modsvaret til nazisternes holocaust.

At vente på det umiddelbart forestående finanskollaps, før man gennemfører Glass-Steagall, er modsvaret til sindssyge. Det vestlige banksystems igangværende dødskrampe er nu forsidehistorie på samtlige finansaviser i Vesten, i en grad, hvor førende »økonomi-kvaksalvere«, såsom Ken Rogoff fra Harvard, foreslår 6 % 's negative rentesatser, plyndring af bankindsynderne og ødelæggelse af, hvad der måtte være tilbage af redelige, kommercielle bankierer. En sådan galskab ville lykkes med at opfylde IMF's forslag fra forgangne weekend, om simpelt hen at nedlukke alle små og mellemstore banker, hvilket vil lade for-store-til-at-lade-gå-ned-bankerne galoppere hen over nationen og den vestlige verden, med pigge på hesteskoene!

Lyndon LaRouche fastslog dette strategiske og økonomiske vanvid som værende en samlet indsats for at forvirre og demoralisere den amerikanske befolkning, der for nylig handlede stolt og modigt for at underkende Obamas veto mod JASTA-loven.

Føj hertil den »inducerede degenerationsproces«, som LaRouche kaldte det, som tvangspåføres befolkningen gennem snavset i præsidentvalgkampen. *»energien i amerikansk politik opbruges i et eller andet drama eller noget underholdning, og kan ikke bruges til at løse centrale spørgsmål«.*

Obamas udvalgte efterfølger, Hillary Clinton, blev i dag afsløret for at have udtalt det indlysende så tidligt som 2014 – nemlig, at saudierne og Qatar »leverede hemmelig finansiel og logistisk støtte til ISIL og andre radikale sunni-grupper«. Og alligevel fortsætter hun, ligesom Obama, med at opfordre til krig mod Rusland og Syrien – ikke mod de nationer, der støtter terrorisme, men mod dem, der er under angreb fra terrorister.

Obama kunne fjernes nu af en samvittighedsfuld Kongres, hvilket også ville transformere den degenererede valgproces. Spørgsmålet er, om en manglende handling for at fjerne ham vil gøre det muligt for ham at trække verden med sig i faldet?

Obama gør krav på et eftermæle for »økonomisk genrejsning«, når narkoafhængighed og selvmord har nået hidtil usete niveauer i Amerika, og dødsraterne i store dele af befolkningen i deres bedste arbejdsår stiger. Han påberåber sig »økonomisk genrejsning«, når han i årevis har ødelagt vores arbejdsstyrkes produktivitetsvækst, elimineret NASA's bemandede rumforskning og lukket udvikling af fusionskraft og fusionsteknologi ned.

Obama gør krav på Fredsprisen, når han har kastet amerikanske

# **Det Russiske Forsvarsministerium advarer mod »Dilletant-illusioner« med hensyn til Ruslands kapaciteter**

*7. oktober, 2016* – Talsmand for det Russiske Forsvarsministerium, general Igor Konashenkov, leverede i går en klar advarsel til dem i USA og andetsteds, der leger med ideen om at lancere direkte militære operationer imod de syriske væbnede styrker – og, gennem forlængelse, imod deres russiske allierede.

Som vi rapporterede i gårsdagens briefing, formandede Konashenkov, der mindede om det amerikanske luftangreb den 17. september imod syriske hærstillinger i nærheden af Deir ez-Zor, hvor 60 syriske soldater blev dræbt, om, at »vi har taget alle nødvendige forholdsregler for at forhindre [en gentagelse af] alle sådanne 'fejltagelser', mht. russisk mandskab og militærfaciliteter i Syrien«. Han forklarede, at de S-300 og S-400 luftforsvars-missilsystemer, der er deployeret til Syrien, ville være en »overraskelse« for alle, der opererer fly over landet. Han advarede specifikt om, at »enhver dilletant-illusion om 'stealth'-fly kunne kollidere med skuffende kendsgerninger.«

Den russiske udenrigsminister Sergej Lavrov talte ligeledes, i sine kommentarer til pressen efter mødet i Moskva med den

franske udenrigsminister Jean-Marc Ayrault, om de luftforsvarssystemer, der for nylig er blevet deployeret til Syrien: »Lad mig gentage: både S-300 og S-500 er rene forsvarsvåben, der ikke truer nogen.«

Lavrov sagde også: »Vi får hele tiden rapporter om, at der er nogle i Washington, der er ivrige efter at anvende magt. Dette er en offentlig hemmelighed. Jeg håber imidlertid, at disse personer ikke får overtaget. Vi har hørt en temmelig afbalanceret kommentar fra Det Hvide Hus, som svar på en forespørgsel om en kommentar til disse rygter. Vi håber inderligt, at dette reflekterer den overordnede politik, som Barack Obama-administrationen fører.«

Lavrov tilføjede, at den russiske præsidents forestående besøg i Paris den 19. okt. vil blive »af enorm betydning«, og han bemærkede, at Frankrigs synspunkter »altid er interessante for os«. Lavrov sagde, at Rusland ville foreslå en tilføjelse til Frankrigs resolution i FN's Sikkerhedsråd (UNSC), som vil kræve en skelnen mellem den moderate opposition, og så al-Nusra-terrorister, og han mindede Frankrig om, at også de er i terroristernes søgelys: »For at forhindre en gentagelse af den tragedie, der fandt sted i andre lande, og i særdeleshed i Libyen, da terroristmitten spredtes i hele Afrika, inklusive Mali, Tchad og den Centralafrikanske Republik, hvor franske soldater også måtte bekæmpe den.«

GET CONGRESS BACK IN WASHINGTON TO PASS GLASS-STEAGALL NOW!

MATTHEW OGDEN: Good evening; it's October 7, 2016. My name is Matthew Ogden and you're joining us for our Friday evening webcast from [larouchepac.com](http://larouchepac.com). I'm joined in the studio tonight by a guest – Paul Gallagher from *Executive Intelligence Review* – and by two members of our Policy Committee via video; Bill Roberts joining us from Detroit, Michigan, and Kesha Rogers joining us from Houston, Texas.

We are in the midst of a heightened mobilization, and I can say that as we speak, copies of the very latest edition of the *Hamiltonian*, the weekly broadsheet from LaRouche PAC, are being distributed in New York City; but also on the streets of

Washington DC outside of the annual IMF meeting. The headline of the *Hamiltonian* this week is very clear; it's titled "One Minute after Midnight, the Crash Is On!" And I think that couldn't summarize our discussion any better here right now. The other articles are also apropos; and if you haven't read them yet, I'd encourage you to. We have "Economics Isn't About Money" by Jason Ross; "Financial Crisis in October; Pass Glass-Steagall Now" by Rachel Brinkley; "One Small Step for Congress, One Giant Leap for Mankind" by Dennis Speed, about the breakthrough with the JASTA veto override; and "Nero Obama Pushes Nuclear Genocide in Final Days" by Carl Osgood.

So, that is now being distributed as we speak; and we already have up-to-the-minute reports from outside of the IMF meeting, where individuals are responding very keenly, including some German economists who personally knew Alfred Herrhausen before his assassination and who are responding to

the voice of Alexander Hamilton via the proposals or the policy perspective that is being laid out by Lyndon LaRouche right now.

What I want to begin with is a very quick brief overview of the crash as it stands, and as it is unfolding over the coming few days and few hours. We will also discuss a little bit of the mobilization that we're engaged in. But we're going to move very quickly from that discussion to an elaboration of what Mr. LaRouche wished to convey as he communicated during the discussion that we had with him a few hours ago. But before we get to that, Paul, let me just ask you to give us a very quick overview of the crisis.

PAUL GALLAGHER: The crash has been on since January 1, 2016. That's when all the rules in Europe were changed so that banks could not be bailed out. Supposedly they were going to be bailed-in; that has turned into meaning the depositors and bondholders were going to have their money taken in order to make new capital for failing banks. That has turned out to be a complete non-starter; it isn't working. It was rejected by Italy, and has basically been thrown up into the air and into the trash basket. So, but nonetheless, they are facing no bail-out; especially Deutsche Bank recently has been facing no bail-out.

Once that occurred, and the price of oil fell into the thirties and around \$40 from nearly 3.5 times that and all the other commodity prices collapsed, that plus the threat of not being bailed out, has meant that not just Deutsche Bank, but dozens of major banks in the countries of Europe, in the United Kingdom, have been at the abyss looking down since then. Simply waiting to see where the trigger for actual loss of all liquidity in that banking system was going to occur; whether it would be in the German banking system, in the Italian banking system, in the nationalized banks of the UK – which are in very bad shape.

That's where this entire banking system has sat since January 1st; tremendously over-leveraged. Eight years, 7.5 years of quantitative easing, which has given them the opportunity to be tremendously over-leveraged; Deutsche Bank is leverage 37:1,

according to a report that just came out from the Federal Deposit Insurance Corporation. That is worse than the leverage ratio of Lehman when it failed; not much worse, but worse.

At the same time, they've been marinated for eight years in an environment of 0% interest rates; which means they are not profitable. They cannot at the same time be prudent and sound commercial banks, and at the same time be profitable. So, what have they done? They have generally shoved aside their taking deposits and making loans – their commercial bank has gone wholly into the shark tank of various speculations; selling elaborate complex instruments which no one understands –

including the salesman. Selling them to their retail depositors, selling them to cities, selling them to towns, selling them to agencies; and essentially trying to loot the deposits in their commercial banking units into their speculative operations, because they can't make money by commercial banking, having been marinated in 0 % interest rates for eight years with essentially an indefinite future of the same stretching ahead of them. So, you reach the crash.

What's being discussed around the IMF meeting, and I think we'll get to it because friends of ours are there; in addition to those of us who are getting out the *Hamiltonian*, there are other friends of ours around these meetings. What's being

discussed there is the potential and the fear of a real liquidity crash being triggered at any moment. What's not being discussed is the crimes that these banks are committing as a result of their speculative culture and as a result of the condition that

they are in after this 8-year marination. The crimes that they

are committing now absolutely demand, as a matter of justice as well as sound banking, that they be immediately broken up.

We don't have to look any further than Wells Fargo, which was supposedly the second-largest bank in the United States, which was supposedly the paragon of non-speculative commercial banking. Look at what they have been doing. Their investment banking and securities units have literally been stealing the money from their depositors by the hundreds of thousands in order to make fees and profits on elaborate instruments. It's criminal. We remember Detroit and all the other cities around the world – around Europe and the United States anyway – which were also sold very complex derivatives, interest rate swaps. Every time they wanted to issue a bond and borrow some money for the city or the town or the transit agency, whatever it was, they were sold these products. It is as good as saying that they didn't know what they had; just like the depositors at Wells Fargo weren't aware of these things they had been sold. So dim was the understanding of the city treasurers and the agency treasurers of these derivatives that the banks were making them buy in order to simply float a bond, that you might just as well say that they sold them those derivatives without the treasurers even knowing that they had them, until they found that they were losing millions and millions of dollars every year. And amazingly, in every single case in every city around the world, the same bet had gone wrong in exactly the same way; and they were running into – in some cases with large cities – into the hundreds of millions of dollars of fines, fees, and losses that they couldn't get out of. This criminal activity can be ended in only one way. That is by enacting the Glass-Steagall Act. If anyone is telling you that by adding yet another specific little

regulation to the thousands of them that are in the Dodd-Frank Act and so forth, that this criminal activity will stop, they are blowing smoke. There is only one way to stop it. Without Glass-Steagall for the last nearly 20 years, you have had every major bank get much larger, and turn into a boat in the

middle full of depositors with a large – in some cases hundreds and thousands of sharks, which are the speculative units of this

immense holding company – all those sharks swimming around the boat full of depositors, and trying in one way or another to get some blood, to get a limb, to get a whole body, to get blood out of there.

The only way you can return even in an individual huge bank like that, to say give us back a bank which can do commercial banking, which can take in deposits and make loans and actually invest in industry and progress, give us that back. There's only one way to do it; and that is to get out your spear gun and kill

those sharks. The way to do that is enact the Glass-Steagall Act; put it back in effect. Essentially, you make such a fence around the deposits then that the sharks absolutely have no access, and you will find that those speculative units – many of them – will rapidly be bankrupt. We're very welcome to hear a proposal from a legislator in Hamburg in Germany yesterday, to do exactly that with Deutsche Bank. If it can be done with Deutsche Bank, as Lyndon and Helga LaRouche proposed a couple of months ago, then it can be done with any major bank in the world. If you can actually get back a real bank, a commercial bank, a lending bank out of that monstrosity, that mess which is Deutsche Bank today – in the process of failing; then the only way to do it was the proposal this legislator made. The same proposal, that Lyndon and Helga LaRouche had made two months ago known as the Herrhausen Proposal for Deutsche Bank. That legislator said, separate and in an orderly way, run down, eliminate all of these toxic, speculative units. Then the commercial bank may be capitalized, even by the government, in such a way that it begins to invest seriously in the economy.

So, that's what's not being discussed; is the crimes and how to stop them. That's a much more fundamental question than which of these banks is going to go first and be the trigger for the general liquidity explosion. We have to get

the Congress to

return. What are they doing having left Washington for two months after saying they wanted to get tough with Wall Street in a series of hearings on Wells Fargo's crimes; then leave the city for two months. Go into recess for a completely meaningless

no-choice election, when instead they should be getting tough with Wall Street; legislating. That's what we're here to discuss, is that mobilization which is now on to get them to go back and restore Glass-Steagall now, and then we'll go on.

OGDEN: Well the smell of that 2008 crash is back in the air for sure; and I think people are beginning to recognize what time it is, as demonstrated in this. This is a headline from the *New York Times* yesterday: "Deutsche Bank as the Next Lehman Brothers". They say, "far-fetched, but not unthinkable"; but remember, that 2008 crash happened exactly during this campaign season, and the Congress came back into emergency session. And at first, voted down the bail-out and then voted the bail-out up. It's that kind of environment; this is what we're seeing. This is an October crisis; this is not something which is going to wait until after the elections. This is not something that's going to wait until the lame duck; and that's the lead on the LaRouche PAC website today. "Send Congress Back To Enact Glass-Steagall Law; Lame Duck Is Too Late".

I don't know Bill, if you want to say a little bit about what the status of that mobilization is, and what people have to be thinking about.

BILL ROBERTS: Sure, Matt. I can confirm that it was my experience when confronting two Congressmen yesterday here in Michigan, and I think some of our super activists have reported a very similar experience. While these Congressmen are paying lip service and while their lips say "Yes, I'm for Glass-Steagall"; their actions say "No." Because as Paul just pointed out, if they were in reality about the fact that

Glass-Steagall is something that must be put in place preemptively, then they would be rushing back to Washington to pass it. The vote to override Obama's veto of the JASTA bill is quite fortuitous, because really if you think about all of the excuses that these members of Congress have: you can't get the two parties together; you can't take on these high-powered lobbyists. In both of those cases, the defeat of JASTA – the justice for the families of the victims – the way that this happened, proves that in fact, it is possible.

This mobilization has got to be accelerated and continued. What our activists are doing—and we are building up a full-scale mobilization on this—is to confront these Congressmen on the full reality of what Glass-Steagall actually is. As Mr. LaRouche pointed out today, Glass-Steagall is just the first of four steps. I think that while many well-meaning people say they support Glass-Steagall, in fact their unwillingness to take leadership on this so far, reflects a lack of understanding of the reality of the situation, how dire it is, and, frankly, a lack of a sense of what Glass-Steagall is, in the sense that this was a real historical bill that was signed into law by Franklin Roosevelt.

When you hear some of these Congressmen, or Bernie Sanders talk about Glass-Steagall, it's just "break up the banks," and that's it. And then they start talking about the abuses of the pharmaceutical industry, as if it's just this sort of gimmick.

But, as Mr. LaRouche has pointed out, this is a strategy, frankly, for victory against genocide. With JASTA, Obama was confronted on his taking the side of an imperial authority to have arbitrary power over people's lives. This is the same exact question. It is even more deadly.

I think it's on that sort of level that this mobilization has to upshift to, to get out of the domain of just a question of "Are you for, or are you against Glass-

Steagall?," but "What is your commitment, now, Mr. Congressman to ensuring that the government intervenes to save the American people, as Franklin Roosevelt did?"

OGDEN: Absolutely! Thank you very much. That, I think, brings us directly to the subject that we discussed with Mr. LaRouche earlier, and this is the subject of our "institutional question," which I'm just going to read. It says, "Mr. LaRouche, you have said that it is absolutely urgent that Glass-Steagall is implemented immediately, and that this is the first step towards a whole series of actions that must be taken to save the economy. Can you please elaborate what the other steps are?" So, that's the question.

Paul, I'm going to let you elaborate a little bit, and then we can also get to the Four Laws, as Mr. LaRouche specifically identifies them.

PAUL GALLAGHER: Well, maybe we'll get to them very quickly, because it brings us really to the question of these two extremely well-known, very fundamentally important figures in history, extremely controversial and very little understood, namely, Alexander Hamilton and Lyndon LaRouche. Certainly the recent efforts to lampoon Hamilton on the stage in New York have not aided at all in people understanding what he really contributed to the human race, to this nation, how he built this nation, in an indispensable way.

We were talking to Lyn LaRouche and Helga LaRouche earlier today about this subject. What Lyndon LaRouche said, repeatedly, actually, was that when he introduced what he called his "Four Cardinal Laws for the Economy" in 2014, he was modelling them directly on the Reports of Alexander Hamilton to the Congress of the United States. Here is where those reports are found, in this book, *The Reports of Alexander Hamilton*, [edited by Jacob Ernest Cooke, II] which gives the four Reports that Hamilton

made to the Congress, through which he established the legislative actions— but they were really broad government actions, based on crucial legislation in each case — which made it possible for this country to survive the extreme bankruptcy which it came into during the course of the Revolution, and to rapidly, from that point on, expand and become the leading industrial and technological power in the world.

What LaRouche was looking at, was four laws and obviously not meaning four traffic laws—four broad actions that must be taken in order to revive the economy from its present zero growth, zero productivity growth state, and nearly zero infrastructure investment, no infrastructure mission. To revive it from that state there are four broad actions which have to be taken, which can be represented and made possible, authorized by legislation, but are really very fundamental.

Glass-Steagall is the first, and must be done *right now*, but it just opens the door. It's like taking out the garbage, as we say. It opens the door to the other actions, and it corresponds very much to Hamilton's establishment on this continent—initially even *before* the Constitution was adopted, and *before* any of his Reports to the Congress were made and the institution of a commercial bank and something whose *only* purpose was to, as he put it, "gather the savings of the country, and place them in the hands of those who could make the most productive use of them."

That idea of a "commercial bank," in the Bank of New York, which he founded; and, obviously, in the Bank of the United States, which he founded, was unique. Before that, you had merchant banks in Europe, which essentially took partnerships in trade ventures and financed trade; and then you had banks which were formed in order to lend to the government, and get control of government finances. The Hamiltonian bank had absolutely neither of those purposes, but rather the purpose which we'll get into, I think, in the

course of this.

OGDEN: Let me just display on the screen, right now, the first slide. This [Slide #1] is the title screen: "The Four Laws, by Lyndon LaRouche." On the next slide [Slide #2] you'll see the link to the actual document which was published by Mr. LaRouche

on June 8, 2014, which we encourage you to read in full. It's titled "The Four New Laws to Save the USA Now! Not an Option: an Immediate Necessity." [<https://larouchepac.com/four-laws>] That's the website you can go to, to read the document in full, and that will also be included in the description to this video, so you'll have access to that as the broadcast continues.

On the next slide [Slide #3] you'll see a very short quote which I've taken from the introduction to that document, in which Mr. LaRouche says the following: "The only location for the immediately necessary action which could prevent such an immediate genocide throughout the trans-Atlantic sector of the planet, requires the U.S. Government's now immediate decision to *institute four specific, cardinal measures: measures which must be fully consistent with the specific intent of the original U.S. Federal Constitution...*"

On the next slide [Slide #4] you'll see "*No. 1: the immediate re-enactment of the Glass-Steagall law instituted by U.S. President Franklin D. Roosevelt, without modification, as to principle of action. No. 2: A return to a system of top-down, and thoroughly defined as National Banking.* The actually tested, successful model to be authorized is that which had been instituted, under the direction of the policies of national banking which had been actually, successfully installed under President Abraham Lincoln's superseding authority of a currency created by the Presidency of the United States (e.g., 'Greenbacks'), as conducted as a *national banking-and-credit-system placed under the supervision of the Office of the*

*Treasury Secretary of the United States*". Mr. LaRouche elaborates after that, that this was the system that Alexander Hamilton created. "No. 3: The purpose of the use of a Federal Credit-system, is to generate high-productivity trends in improvements of employment, with the accompanying intention, to increase the physical-economic productivity, and the standard of living of the persons and households of the United States. The creation of credit for the now urgently needed increase of the relative quality and quantity of productive employment, must be assured, this time, once more, as was done successfully under President Franklin D. Roosevelt, or by like standards of Federal practice..." Next slide [Slide No. 5] "...used to create a general economic recovery of the nation, {per capita}, and for the rate of net effects in productivity, and by reliance on the essential human principle, which distinguishes the human personality from the systemic characteristics of the lower forms of life: the net rate of increase of the energy-flux density of effective practice. This means intrinsically, a thoroughly scientific, rather than a merely mathematical one, and by the related increase of the effective energy-flus density *per capita*, and for the human population when considered as each and all as a whole." Following this, Mr. LaRouche said, "The ceaseless increase of the physical-productivity of employment, accompanied by its benefits for the general welfare, are a principle of Federal law which must be a paramount standard achievement of the nation and the individual."

And then "No. 4." Next Slide. [Slide No. 6] "'Adopt a Fusion-Driver 'Crash Program.' The essential distinction of man from all lower forms of life, hence, in practice, is that it presents the means for the perfection of the specifically affirmative aims and needs of human individual and social life. Therefore: the subject of man in the process of creation, as an affirmative identification of an affirmative statement of an absolute state of nature, is a permitted form of expression.

Principles of nature are either only affirmations, or they could not be affirmatively stated among civilized human minds."

Following this, Mr. LaRouche elaborates the concept of Vladimir Vernadsky's idea of the noosphere, in which he places man as specifically distinct, and in a hierarchy, above other forms of life; and then elaborates the concept of "physical chemistry," as

the only yardstick in the science of economics.

So, again, that document, in full, is available to you at <https://larouchepac.com/four-laws>. The link is available in the description to this video. We encourage to read that and study that, in full, along with these Four Reports that Paul mentioned—the Four Reports by Alexander Hamilton to the United States Congress. With that said, I think we can open up, especially this fourth point, that I just named here, and I invite Kesha to say a little bit on this subject.

KESHA ROGERS: Okay. Thank you Matt. I think we really have to start with the unstated-but-consuming principle that exists in all four of those Laws. Mr. LaRouche really captured this in recent discussions: that mankind has to re-discover the meaning of "mankind," and what is the purpose by which we, as the human

species, exist? What is our purpose, in terms of promoting the power of the creative potential that lies only in the human species, unlike any other species.

When you think about the Fourth Law, people start to say, "Ah, Okay. Well, you know, LaRouche is promoting nuclear power and fusion power, and so forth." It's not just about that. It's a subsuming principle of *all Four*, that starts with, what I would

define as the principle of Agapé. How do you develop Glass-Steagall? How do you develop the credit system, in the way that Hamilton understood, in the way that LaRouche understands? It comes from the understanding of the benefit to all mankind, which exists in advancing the creative potential

for all mankind.

If you really look at how that has influenced our nation, under Presidents George Washington, and particularly in Roosevelt and John F Kennedy. These Presidents didn't just look at Hamilton's conception of national credit, Hamilton's conception

of development of economics from the standpoint of just the law. It started with the understanding of a unique principle in the United States to advance the productive and creative powers of every living being in this nation and on this planet. One thing

that we talk about is what you saw under President Franklin Roosevelt, who was a devout student of Alexander Hamilton, and really what expanded from the period of Franklin Roosevelt through the period of John F Kennedy, was what named as the Golden Age of Productivity. I think that what we need right now is a Golden Age of Productivity for the world.

Where is the opposition coming to this? Well, if you look at what has happened with the attacks on our US space program, which would be the defining principle, the defining process which would bring together new scientific discoveries for mankind;

revolutionizing science in the way that we should be doing, which is our human potential. That's what Obama rejects. When Obama said that we don't need any fancy fusion, and now you've seen not only the shutdown of our manned space program; but now the potential for advancements in new creative breakthroughs of

scientific and technological advancements that exist through programs such as the fusion research centers and development programs at MIT and Princeton. That's being shut down because we didn't go with Glass-Steagall; we didn't go with the Hamiltonian credit system to actually put the necessary credit into these great scientific endeavors and large scale infrastructure projects. This isn't just happening because somebody thinks the money should go elsewhere. It's happening because of a rejection to this truly human identity that it is

our human nature to advance to provide for the future; to bring about the creating of a future. So, when you think about what we're up against here, when people say "Oh yeah, we need to break up the big banks and we need Glass-Steagall"; we need Glass-Steagall, we need to break up the big banks, but we need it on Hamilton's terms. We need it on LaRouche's terms from the standpoint of a higher conception.

We have to stop the death rate; we have to stop the mass killing in the United States and around the world. The way we're going to do this, is that these programs have to be implemented from the standpoint of a higher definition and conception of what it means to be human.

I think that gets us to a fundamental point of why you look at what China is doing with the development of their space program – and LaRouche has really emphasized this very emphatically – that China has to be a model from the standpoint of the space program. Not just because of a singularity of a program they're taking up, because China's now going to the far side of the Moon, unlike any other nation; doing something that no one else has yet to do. What does this mean? This is a breakthrough in a revolution in science; this is a breakthrough in the benefit and the potential progress to all mankind. I think that is where LaRouche's Four Laws have to start from; and what China is doing right now is what we in the United States, the foundation and the principle of this United States was founded on.

What our great visionaries and scientists understood was the unique principle of mankind that defies this oligarchy's rejection of that identity; and why we became a nation committed to this principle of the creative, productive powers of the human species. If you think about these visionaries from the standpoint of what China and nations around the world are

doing to advance this creative potential, it can really be stated and defined in what the great space pioneer Krafft Ehrlicke again outlined as what our true extra-terrestrial imperative as a human species is. One thing I wanted to point is – again, I've stated this on a number of occasions – we brought up Krafft Ehrlicke's three laws of astronautics and what this really represents to promoting that potential. But I want to focus in very quickly on the third law, which is not always stated as clearly as it could be; but I think it really captures this idea that he says, "By expanding through the universe, man fulfills his destiny as an element of life; endowed with the power of reason and the wisdom of the moral law within himself." I guess the point is, where does this power of reason come from? Where does this moral law and nature within the existence of mankind lie? And it lies in mankind's creative potential, the discovery that exists only in the human species to be able to introduce new scientific principles; to introduce new laws that no other animal species can do. This is what we're losing sight of right now.

But the thing is, if we allow for the human population to be killed off en masse, we take away that potential. Look at what's happening right now: the death rates; what's happening with the drug overdoses, the suicides. What's happening with the fact that nations are dying because we don't have the scientific and technological advances to deal with threats that occur in terms of threats that come with natural disasters, that we could be saving lives. Look at the numbers of people that are going to die in Haiti right now. All of this could be stopped if we actually had a program in place immediately; a global Glass-Steagall. So we can actually stop the death rate and organize people around saving human lives so that we can advance for the future; so that we can put forth a new meaning of what mankind and the future of mankind must be. That's where the Four Laws lie; that's where we have to get Congress, as you said, back in Washington DC right now. Because they have a responsibility

to this nation and a responsibility to mankind. The fact that Obama rejected the offer by China for cooperation, rejected the offer by China to be a member of the Asia Infrastructure Investment Bank and to be a part of the New Silk Road Development

Plan, already tells you – once again – his commitment is not to the advancement of the people of this nation and the people of the world. It is to this financial oligarchy, to this empire, and to the purpose of death that he has been promoting for far too long and cannot continue to get away with.

OGDEN: Yeah, I'm actually glad you brought up the AIIB, the Asia Infrastructure Investment Bank, because one of the other elements that Mr. LaRouche raised in the discussion that we had with him this afternoon, was the necessity for international development bank banking types of activities. That there has to be a commitment on the level of agreements among nations for these vast development projects, and a Hamiltonian banking system which will allow these to take place. We see the emergence of this with what China is doing and some of the other collaborative programs around the development of the New Silk Road. This is the kind of vast surge in productivity and increased standards of living that we see in places of the world that have suffered almost no development. The interior of Eurasia and elsewhere.

But it's something that the United States had originated over 200 years ago with what Hamilton conceived; and it's something which the United States is in no way participating in today. In fact, it's rejecting and attempting to shut down – as you said Kesha. So, that's something that Mr. LaRouche also introduced into the discussion. Maybe it's something that we can also discuss a little bit more of.

GALLAGHER: At this IMF meeting, the IMF introduced a report on the world economy, and they said the big problems are: no

growth, most especially including in the United States and of course in Europe; in Obama's recovery, no growth at all; and too much debt. What did they propose as a solution? To cut back credit all over the globe, and especially to insist that China and India – which are the only two engines of real economic and industrial growth in the world – should cut back their issuance of credit. That tells you that there is functional insanity at the top of the IMF; they are completely unaware of the relationship between credit and debt. It is in fact the case that what Alexander Hamilton did â; The United States now needs a

national investment bank; it needs a national infrastructure bank, whatever you want to call it, it needs a national bank with that purpose. What Alexander Hamilton created, as LaRouche in the second of his Four Laws, was essentially a bank which he said was needed in order to be the liaison between the government and the private banks. In the process, again remember that characterization of gathering the savings of the country and placing them in the hands of those who could make the most

productive use of them. So that Hamilton was able to actually reorganize the debt of the United States and the states – which was largely unpayable at that time; provide a means of extinguishing it over a long period of time and redirect that reorganized debt through a bank into new credit, the purpose of which was to go into the key areas of the development of the productivity of the new American labor force. It could have been coming to the third action LaRouche is talking about, Hamilton

was most controversial there, because the bank that he created to reorganize the unpayable debt of the United States and the states and make it into credit; that bank could have been a land bank, that was what was being done in Europe. Alexander Hamilton had studied all those experiments of Turgot and all the other national land banks which had been set up, which had the effect of perpetuating agriculture as really the only economic activity in the country, and of enriching farmers.

But of course, it tended to enrich the monopolists who got control of the production of farmers. It also potentially that effect.

Hamilton said, no, that is not what we want to be as a nation. We don't want a national bank to finance unchanged farming practices all the way to the Pacific Ocean; which is what Jefferson wanted, and other. Rather, we want the farms to become the market for truly creative new manufacturing and industrial development – craftsmen, artisans, the founders of manufacturing businesses. This is what our national bank, said Hamilton, has to bring about; not just the endless extension of farming, the basis of the government finances on a national land bank.

What LaRouche specified – and again, as he was saying, he was thinking of Hamilton's Four Reports to the Congress in his Four Laws; what he specified is then the national bank's credit must be invested in truly productive infrastructure investment.

We're not going to get productive by investing in endless fields of solar mirrors out in the desert, or making a desert out of what was previously just a plain. We're going to become more productive by investing in the most advanced infrastructure

investments and missions that the country could possibly have.

That brings us directly to Kesha's conceptual overview, particularly of the fourth critical action; what LaRouche called the Fourth Cardinal Law, that there are frontiers of science. We know that the exploration of deep space, reviving that with everything that goes with in terms of the human experience and also in terms of developing new means of studying, measuring, and changing potentially, the laws of the universe; Einsteinian action in exploration of deep space. That requires that we have a major effort such as that which collapsed in the late 1960s when NASA's budget essentially, virtually disappeared overnight just as we were landing on the Moon. There was not a Hamiltonian credit institution backing

that space exploration, that Apollo project, up; and its budget suddenly disappeared.

We need, according to LaRouche's outline of these actions that have to be taken, to put that on the basis that we are going to go fully at the frontiers of science. Go with China to the other side of the Moon, from which the universe can be studied

and observed in a way that it never has been before. Take the Moon's long view of the universe and bring it back and share it with all the nations of the Earth; which is what the Chinese space administrator at the conference in Mexico last week was

committing China to. So, we also have to make this international, as LaRouche specified. It is a crime that whereas China has created the institutions of credit – the New Silk Road Fund, the AIIB that Kesha raised – the so-called policy banks which make trillions of dollars in infrastructure at home and abroad. Where it has created, one hand reached out for an actually international credit and sound banking system, the United States has not responded. It has no national banking institution; does not have, for the most part, sound and prudent banking going on in the private commercial banking system either.

Germany – the other critical economy in the trans-Atlantic region – same thing; no such national institution. The Kreditanstalt für Wiederaufbau which they built up after the war, has practically been eliminated; and therefore, no hands coming from the trans-Atlantic side, from the European economies join with that initiative of China, either in the exploration of space, or in the creation of the credit for it. Therefore, this terrible predicament that our friends reported and are experiencing who are at the IMF meeting; that they are somehow trying to reduce the runaway indebtedness of the world by cutting off the new credit which could actually – if directed as Hamilton and LaRouche say – if directed into the frontiers of science and technology, could actually make

that debt manageable; both by being written off and also by being made whole in the long term.

This is where Glass-Steagall is intended to lead, is into these kinds of actions. By first putting an end to the crime syndicate which has taken the place of major banks, and breaking it up and making the rest of these crucial actions possible.

But, as Bill said, we have a lot of members of Congress – why not name a few? Maxine Waters, who in the hearing on Wells Fargo said, "I'm introducing legislation to break this bank up; and if it breaks the other banks up, so be it." She's not a sponsor of the legislation which would break that bank up in the way that

would actually make for sound banking. A whole bunch of Senators at the Democratic Convention, who were interviewed on the floor in a television video, and said they were absolutely for restoring Glass-Steagall; but haven't sponsored the legislation: Senator Stabenow; Senator Booker of New Jersey; Rep. Sherman of

California. There are so many members of Congress, who are not putting their sponsorship and their action where their – they're like on Facebook. They "like" Glass-Steagall, but that is the end of it; they haven't done what they have to do.

So, get like-minded friends of yours and associates, people you know who, like you, support Glass-Steagall, and ambush these Congressmen with bunches of calls all at once to their offices demanding this. Ambush them as Bill was talking about, at the many town meetings and public appearances that they'll make.

We've got to get them to go back to Washington and take the action against Wall Street before this crash wipes us out.

ROBERTS: Let me make one more point, too, which is that Glass-Steagall has enjoyed popular support for years; it's in both party platforms. Why hasn't there been a hearing on Glass-Steagall when you have 130 members of Congress that support

it? Well, it's simple – because of Obama. It's the same reason that Obama has sabotaged Glass-Steagall is the same reason that Obama sabotaged the space program. Because the space program is the one area, as Kesha was developing, where it's completely transparent that the real nature of the human species and the real nature of economics is the Hamiltonian conception of the increase of productive powers of labor and of real physical economic growth that's generated through the discovery of new principles. You can't have a space program without that; you can't send human beings out into space and conquer the Moon and other domains. There's no pie to divide up; space is infinite. It just becomes utterly clear; it's like this experience that's been related by so many astronauts that go up to the Space Station. They look down at the bright blue Earth, and they say, "Well, I don't see any borders. I see these little land masses." And it becomes very clear to them that we are one unified humanity; and that is something that Obama had to kill. So, just as in the case of the JASTA vote, Obama has to be confronted; there's no nice way about this. He's the reason why this has not happened. I just wanted to make that point clear.

OGDEN: Absolutely! He was rendered impotent over this historic defeat of his veto of the JASTA bill. All of the so-called practical political arguments that people presented to you over years and years – "Oh, we're for Glass-Steagall, but it's just not – we can't politically make it happen." All of those crumbled with this historic victory, secured by the activation of the American people to create the conditions in which Congress had no choice but to override Obama's veto. All of these arguments against the immediate re-enactment of Glass-Steagall have crumbled. There's no better opportunity than in the wake of that victory with the restoration of the confidence of the American people that in fact, you can force this kind of historic political change to happen through this kind of mass-based activation. Coming off of that victory,

it's the time to create the political climate in this country in which if Congress does not return to Washington to immediately re-enact Glass-Steagall; that that's a toxic environment. And the American people know how to make that happen; we can do that, we can lead that. It's the kind of climate in which if you were clear as to how close we are to a total disintegration of this trans-Atlantic system, you wouldn't think twice about doing that.

And any Congressman who's trying to escape from the reality of what it would mean for Deutsche Bank with all of the derivatives counterparties to go through the floor; that this would be far, far worse than the Hell that was experienced in 2008. That would be a collapse from which you could not recover; you can't bail your way out of that kind of crisis.

So, it's only through the immediate re-enactment of Glass-Steagall – but also, as you made the point, Bill, I think very clearly – knowing that Franklin Roosevelt created Glass-Steagall in the context of the entire program that he instituted with his Presidency. The full weight of the FDR program has got to be present with the first step that's taken with re-enacting Glass-Steagall.

ROGERS: It's important to bring out what we put out as a standard in the report we published – which people should go back to – "The United States Joins the New Silk Road; a Hamiltonian Vision for an Economic Renaissance" – because I think that captures the essence of what we have to seek to bring about. Not just an economic recovery, not just putting a few people back to work; but we need a whole, complete breakthrough. A revolutionizing of science in the way that LaRouche is calling

for; a revolutionizing in the conception of the nature of mankind; what it means to be human; what we are as a species. And then how we bring together the conception of mankind for the benefit of all from the standpoint that we are now going to

advance and share in the greatest potentials for mankind that

ever existed. That's found in, as Krafft Ehrlicke said, "leaving the confines of one small planet" and going out into conquering and development of space. I thought that Bill just said it well;

that that exists not from the standpoint of borders, or from the standpoint of competing for resources. This is not about competing for resources or existence of borders; but it's that we have a unique potential as a species to come together and to act to create this economic renaissance as it's never been defined before.

I think that is really what we have to get the emotional quality around, as we saw an emotional drive around this JASTA fight. It wasn't just about the families of 9/11; but this was the question of the fight for human beings. The fight that existed really took place in people starting to sing together. When people sang together, the power that they found within themselves with the development of what took place with the

Living Memorial concerts as one; but the principle that people started to really sing together and to realize that they had more power against this enemy than they ever thought existed. And they acted on that power. We have to do the same right now to realize that this evil can be and must be defeated.

OGDEN: Wonderful. So, I think that with the title of this week's *Hamiltonian* – "One Minute After Midnight" – we can proceed with the correct sense of urgency; and everything that has been said today defines exactly what the mission is. So, again, if you can read the full document – LaRouche's Four Laws – which is provided in the link in the description to this video, that's available. And secondly, the Four Reports by Alexander Hamilton; this is available as a book. Jacob Cook is

the editor of this version; it can be made available as well. And please read these in conjunction, and maybe that can be

the subject of your Congressman's next town hall meeting.

## **António Guterres næste generalsekretær for FN**

*6. oktober, 2016* – Under Ruslands præsidentskab vedtog FN's Sikkerhedsråd at udnævne tidligere portugisiske premierminister António Guterres som den næste generalsekretær for FN som efterfølger for Ban Ki-moon fra 2017. Alt imens Guterres var favorit, var det ikke forventet, at han ville blive valgt så tidligt. Han vandt et absolut flertal, med 13 af de 15 medlemmer af Sikkerhedsrådet, der stemte for ham, og to, der undlod at stemme. Alle de fem permanente medlemmer stemte for ham.

»I dag, efter vores sjette uofficielle prøvevalg, har vi en klar favorit, og hans navn er António Guterres«, sagde den russiske FN-ambassadør Vitaly Churkin til reportere, med sine 14 rådskolleger stående bag sig. »Vi har besluttet at gennemføre en formel afstemning i morgen tidlig kl. 10, og vi håber, det kan gøres gennem mundtligt tilsagn.«

Mange iagttagere havde forventet, at udvælgelsesprocessen ville fortsætte til langt ind i oktober, med de største magter, der kæmper om at promovere deres favoritkandidat. På trods af påstande om, at Rusland, der i øjeblikket har præsidentskabet for FN's Sikkerhedsråd, ville blokere for Guterres, proklamerede Churkin entusiastisk valget af

Guterres.

»Jeg tror, at russerne sluttelig ønskede, at afgørelsen skulle komme under deres præsidentskab, og at hele sikkerhedsrådet skulle træde frem og stå forenet på et tidspunkt, hvor der er så megen dyb splittelse om andre spørgsmål«, sagde en diplomat fra sikkerhedsrådet.

Guterres har været FN's flygtningehøjkommissær og ansås for at være meget ligefrem mht. flygtningespørgsmål. Han sagde, at det ville han fortsat være som generalsekretær.

»Mit engagement er totalt pga., hvad jeg følte som chef for UNHCR i 10 år«, sagde han under en debat mellem kandidater, præsideret af avisen *Guardian* denne sommer. »Man kan ikke forestille sig, hvordan det er at se en sådan grad af utrolige lidelser.«

# **Rusland overtager præsidentskabet af FN's Sikkerhedsråd; Frankrig foreslår udkast til resolution om Syrien**

4. oktober, 2016 – Rusland overtog præsidentskabet af FN's Sikkerhedsråd (som går på skift) i denne uge, og den russiske ambassadør til FN, Vitaly Churkin, fremlagde under en pressebriefing i går en ambitiøs arbejdsplan for de næste fire

uger, inklusive et russisk initiativ til at gøre den ekstremistiske ideologi bag terrorisme til målskive.

Samtidig cirkulerede Frankrig og Spanien i går et udkast til en resolution om Syrien, der har til hensigt at sætte Rusland i forlegenhed. Churkin understregede, at enhver UNSC-resolution om konflikten må inkludere en samlet aktion imod terrorgrupper.

»Hvis ideen med udkastet til en resolution er at bevæge os hen imod et ophør af fjendtligheder, så vil en blot og bar resolution faktisk ikke virke«, sagde han. »Det, der kunne virke, ville være, hvis vi aftalte stærkere fælles aktioner imod terrorister, for ophør af fjendtligheder skal angiveligt ikke gælde for terroristgrupper.«

Det fransk-spanske udkast til en resolution kræver imidlertid en standsning af de russiske og syriske luftvåbens flyvninger over Aleppo (de siger »alle militære flyvninger«, men det gælder tydeligvis kun for syriske og russiske militære flyvninger), samt en ny, FN-overvåget kontrol af en våbenhvile, og udkastet truer med »yderligere forholdsregler«, ifald nogen part ikke overholder våbenhvilen. Churkin afviste flyveforbuddet som en dødsejler. At have en resolution, der »ensidigt rammer flyvning, hvor terrorister [på jorden] ville få mulighed for at gøre præcis, hvad de har lyst til, ville ikke være noget særligt attraktivt forslag«, sagde han. Men franskmændene håber tydeligvis på, at de kan tvinge russerne op i et hjørne med resolutionen. Ifølge Reuters har den franske udenrigsminister, Jean-Marc Ayrault, sagt, at enhver stat, der modsætter sig resolutionen, ville blive dømt medskyldig i krigsforbrydelser, rapporterer Reuters. Dømt af hvem? Dette forklares ikke, men det måtte være de samme støtter af de terrorister i Syrien, som russerne bliver ved med at nævne ved navn.
